

#### AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT WITH CIVICPLUS LLC. FOR SEECLICKFIX SUBSCRIPTION, TRAINING AND APPLE/ANDROID APPS

This Amendment No. 1 is entered into as of \_\_\_\_\_ \_, (Effective Date) by and between the City of Milpitas, a municipal corporation of the State of California (hereafter referred to as "City") and CivicPlus LLC, a limited liability company (hereafter referred to as "Consultant"). City and Consultant are sometimes individually referred to as "Party" and collectively as "Parties" in this Amendment No. 1.

#### **RECITALS:**

WHEREAS, on May 31, 2019, the City entered into a Professional Services Agreement (hereinafter, the "Agreement") with SeeClickFix, Inc. for SeeClickFix Subscription, Training and Apple/Android Apps to be provided to the City, with a term period of June 1, 2019 through May 31, 2024, and a maximum compensation amount of \$90,000.00; and

WHEREAS, on April 9, 2021, the Parties entered into an Assignment and Assumption of Contract agreement effective as of October 9, 2019 due to the merger of SeeClickFix Inc. and CivicPlus, LLC, whereby the Agreement was assigned to and assumed by Consultant; and

WHEREAS, the Parties now desire to amend the Agreement to increase the compensation amount by \$6,000.00 to purchase an upgrade to provide SeeClickFixhosted integration with Lucity (CentralSquare Technologies) with Service Requests and Work Orders.

NOW THEREFORE, in consideration of the mutual covenants and conditions herein contained, the Parties agree to amend the Agreement as follows:

- 1. Section 2 Compensation. Section b. is amended to read as follows: In no event shall the total amount paid for services rendered by Consultant under this Agreement exceed the sum of **Ninety-Six Thousand Dollars** and Zero Cents (\$96,000.00). Annual license fees will be paid within thirty (30) day of receipt of an invoice which includes a detailed descriptions of the work performed.
- 2. Exhibit A, Scope of Services, is hereby amended to add Exhibit A-1 (April 2021 Service Enhancement), attached hereto and incorporated herein by reference.
- 3. Exhibit B, Schedule of Charges/Payments, is hereby deleted in its entirety and replaced with Exhibit B-1, Revised Schedule of Charges/Payments, attached hereto and incorporated herein by this reference.
- 4. All other provisions of the Agreement not amended by this Amendment No. 1 shall remain in full force and effect.
