### **SUMMARY:**

A non-partisan general election will be held on November 4, 2025, for Milton Mayor and the Council Seats for District 1/Post 1, District 2/Post 1, and District 3/Post 1. Pursuant to O.C.G.A. § 21-2-131(a)(1)(A), the City Council for the City of Milton is required to fix and publish the candidate qualifying fees by February 1, 2025 for each municipal office to be filled in that year's general election. Additionally, O.C.G.A. § 21-2-131(a)(1)(A) provides that candidate qualifying fees shall be three percent (3%) of the total gross salary of the office paid in the preceding year of a salaried office.

The 2024 gross salaries, including supplements, for the Mayor was \$29,800. The annual compensation for the District 1/Post 1, District 2/Post 1, and District 3/Post 1 Council positions was \$19,800. The following qualifying fees shall apply to candidates seeking municipal office in the election to be held on November 4, 2025:

# RESOLUTION OF THE CITY OF MILTON, GEORGIA TO SET CANDIDATE QUALIFYING FEES FOR THE 2025 MUNICIPAL GENERAL ELECTION

**WHEREAS**, in compliance with Section 2.11 the Charter for the City of Milton and Title 21 of the Official Code of Georgia ("O.C.G.A.") which governs elections, a non-partisan general election will be held on November 4, 2025 for Mayor and the Council Seats for District 1/Post 1, District 2/Post 1, and District 3/Post 1; and

WHEREAS, pursuant to O.C.G.A. § 21-2-131(a)(1)(A), the City Council for the City of Milton is required to fix and publish the candidate qualifying fees by February 1, 2025 for each municipal office to be filled in that year's general election; and

WHEREAS, O.C.G.A. § 21-2-131(a)(1)(A) provides that candidate qualifying fees shall be three percent (3%) of the total gross salary of the office paid in the preceding year of a salaried office, including all supplements authorized by law; and

**WHEREAS**, the 2024 gross salaries, including supplements, was \$29,800.00 for the Mayor and \$19,800.00 for the District 1/Post 1, District 2/Post 1, and District 3/Post 1 Council posts; and

**NOW, THEREFORE**, **BE IT RESOLVED** the Mayor and Council of the City of Milton, Georgia, pursuant to their authority do hereby adopt a Resolution as follows:
