OLD BUSINESS

Amend and Adopt the Water and Sewer Rates

Water rate increase amended to 29%, down from the original 31% suggested amount. The rate increase will take effect July 1.

Motioned by Covert and seconded by Chapman.

Mayor Jarvis questioned if the Town was in danger of having any critical infrastructure issues regarding the water pipes. Council member Covert noted that it is not predictable due to outside factors, such as an aftershock. The Town Manager mentioned that the biggest water issue the Town is facing is leakage. Mrs. Washington believes that the 29% is enough of an increase, as well as the grant money, is enough to fix the system. Mrs. Washington also suggested to Council that the Town hosts a quarterly town hall meeting so citizens can voice their concerns as well as show the Town's progress. The Town will also look into using a Facebook page as a way of communicating with citizens.
