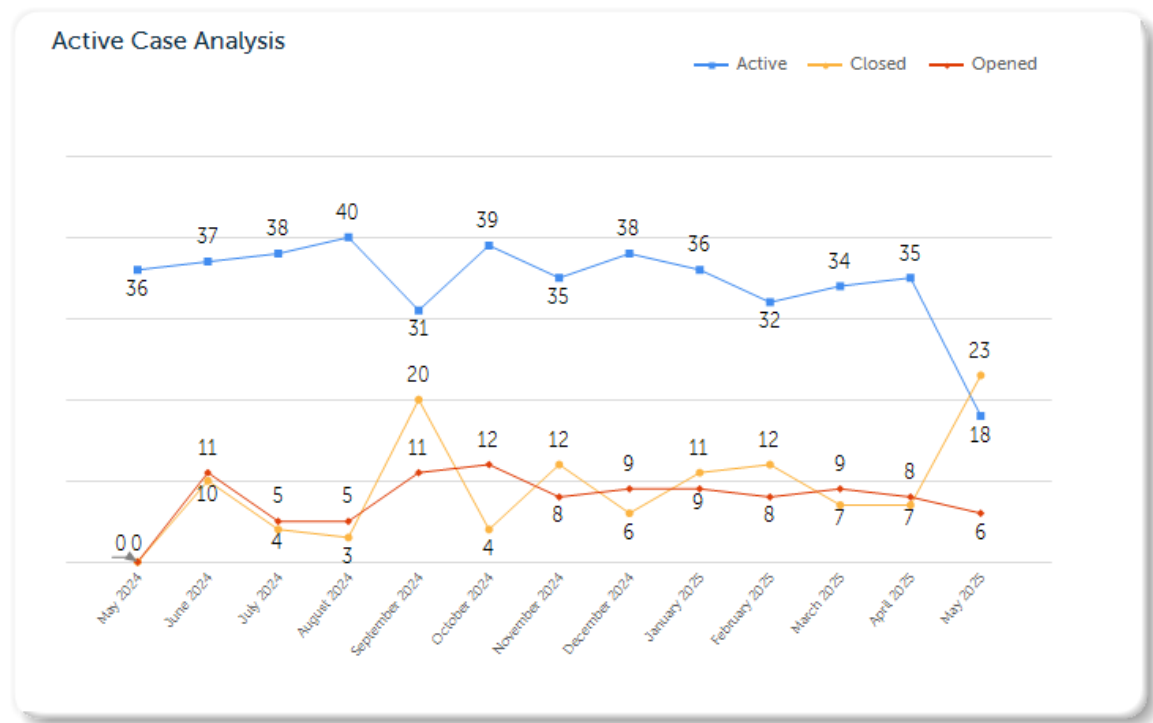
Madame Mayor and Members of Council,

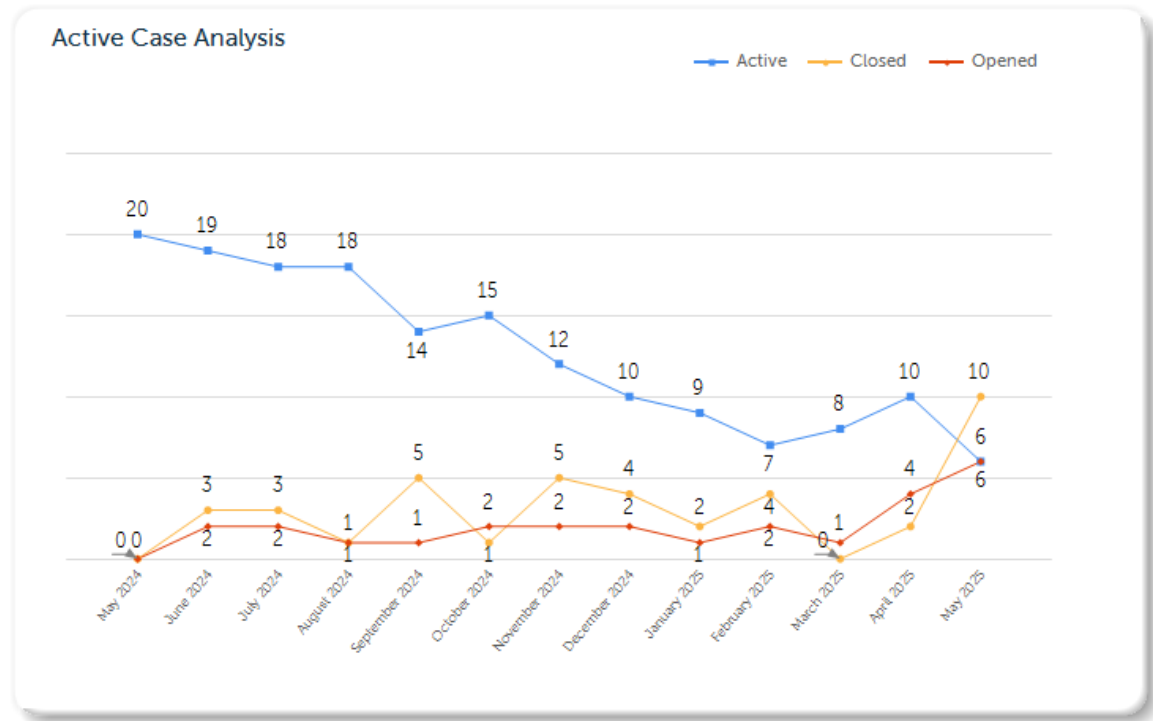
