## **Request**

Council is asked to approve Resolution 43 - Series 2024 authorizing the Mayor to sign a contract with Tatanka Historical Associates, Inc. in order to execute a Historic Resource Survey.

#### Introduction

The Town received a \$25,000 grant from History Colorado to conduct a Resource Survey with. A committee conducted interviews after sending out a Request for Proposals (RFP) and are recommending to the Town Council that they authorize the Mayor to sign a contract with Tatanka Historical Associates, Inc.

#### **Analysis**

Town staff sent out an RFP soliciting proposals to help the Town conduct a Resource Survey. The Town has committed \$1,600 of Town funds to this endeavor, so together with the \$25,000 grant, there is a budget of \$26,600. In response to the RFP, the Town received five proposals. A committee consisting of Historic Preservation Commissioner Kelly Toon, Town Manager Michelle Metteer, and Planner I Madison Harris interviewed all five respondents. After evaluating both the submittals and the interviews, the committee decided on Tatanka Historical Associates, Inc.

# **Community Input**

Proposals were solicited through the Vail Daily, the Town website, and Bidnet.
