Re: Proposal for Grant-Writing Services for FY2025

Dear Ms. Michelle Metteer,

On behalf of Sustainable Strategies DC (S^2), I am pleased to provide this proposal for grant services to the Town of Minturn ("the Town"). S^2 has extensive experience helping localities secure resources for affordable housing, transportation and water infrastructure, historical restoration, economic development, community revitalization, and other priority projects. S^2 has worked with the Town of Minturn since 2021 and understands the Town's key funding priorities, including the implementation of a capital improvement plan for the Town's water infrastructure, as well as the completion of several road, sidewalk, and bicycle amenities projects and new housing developments including the Minturn North project.

S² provides a proposal for implementation assistance, including developing an Update Resource Roadmap, first completed in August 2021. This letter includes a proposed scope of work, compensation arrangements, and background on our firm and our team.

SCOPE OF WORK

S² proposes to include grant-writing services for three (3) to four (4) funding opportunities (depending upon size/level of effort of grant proposals) over a one-year contract period beginning in January 2025. S² will engage the Town team to carry out these services most effectively through:

- Update Resource Roadmap to reflect changes and updates to Minturn priorities;
- Performing **ongoing grant services**, including:
 - o Providing **strategic advice** to help shape projects to be more competitive for foundation, federal, state, and other funding opportunities;
 - Working with the Town team to identify and gather **stakeholder support** for funding projects from the right local, regional, state, and national partners;
 - Providing full-service grant-writing, including drafting, finalizing, and submission of narratives, stakeholder support letter templates, attachments, and other components of competitive proposals;
 - o Conducting grant review of proposals prepared by the Town and stakeholders;
 - o **Submitting grants** through Grants.gov or other means.
- Conducting regular conference calls and communications with the Town team to provide updates on grant opportunities;

- Regularly updating the funding agenda to include new projects and grant opportunities;
- Connecting the Town team to the appropriate federal, state, and philanthropic officials to advocate for pending funding proposals.

PROPOSED FEE FOR SERVICES

S² proposes a monthly retainer of \$4,500/month to provide full grant-writing services to pursue these funding opportunities over a one-year contract period. Should you think you will be interested in pursuing more than four (4) grants, we can adjust the proposed fee structure up-front or discuss a means for adding grants and/or months to the retainer as we go.
