**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MISSION, TEXAS
DECLARING CERTAIN LAW ENFORCEMENT SUPPORT OFFICE (LESO)
PROGRAM PROPERTY AS EXCESS PROPERTY AND AUTHORIZING THE
TRANSFER OF SAID PROPERTY TO ANOTHER PARTICIPATING AGENCY AS
ALLOWED BY LESO PROGRAM.**

WHEREAS, the City of Mission is a home-rule municipality; and

WHEREAS, included among the management responsibilities of public property is the authority and duty to declare property determined to be of no further use to the City to be excess; and,

WHEREAS, excess property is personal property that is not needed or required for an entity's foreseeable needs but still has some usefulness for the purpose it was originally intended; and

WHEREAS, the City is allowed to transfer or return Law Enforcement Support Office (LESO) property that is found to be in excess and no longer of use to another participating agency as outlined by LESO; and

WHEREAS, the City has determined that the transfer of said excess property seen in Exhibit A of this resolution would be beneficial to the City and serve a public purpose.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MISSION, TEXAS:

Section 1. The City Council of the City of Mission, Texas hereby declares the LESO property listed in the attached **Exhibit A** as excess property, and authorizes the City Manager, as the Civilian Governing Body Official (CGBO), and Chief of Police, as the Chief Law Enforcement Official (CLEO), to transfer said property to another LESO participating agency, as allowed by the LESO program.

Section 2. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the City Council.

Section 3. All resolutions or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.

Section 4. This Resolution shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

Section 5. If any provision of this Resolution or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Resolution and the application of

such provision to other persons and circumstances shall nevertheless be valid, and the City Council hereby declares that this Resolution would have been enacted without such invalid provision.

Section 6. It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Chapter 551, Texas Government Code, as amended.

Section 7. This Resolution shall be in force and effect from and after its final passage, and it is so resolved.
