**2<sup>nd</sup> AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT BETWEEN  
THE CITY OF MISSION AND THE COUNTY OF HIDALGO, TEXAS FOR  
EMERGENCY MEDICAL SERVICES**

This Amendment to the Interlocal Cooperation Agreement is made on this 10<sup>th</sup> day of November, 2025, by and between HIDALGO COUNTY, TEXAS by and through its Office of Emergency Management hereinafter referred to as "County," and the CITY OF MISSION, TEXAS hereinafter referred to as "City".

**WHEREAS**, County and City entered into an Interlocal Cooperation Agreement on December 19, 2023, pursuant to the provisions of the Texas Interlocal Cooperation Act, Texas Gov't Code 791.001 et seq., in an effort to ensure the provision of emergency ambulance services to residents of Hidalgo County, and specifically those located in Precinct #3, and the CITY agreed to assist with providing such services as noted in defined Service Area(s) for the public purpose of preserving and protecting the public health and safety of the residents of the County;

**WHEREAS**, the term of the agreement is for one year beginning January 01, 2024, and terminating on December 31, 2024, with the option to extend for an additional three (3) one-year terms at the same rates, terms and conditions through mutual agreement of both parties;

**WHEREAS**, on or about November 15, 2024, the Parties executed the first of the three additional one-year extension periods available to the parties; and

**WHEREAS**, the Parties now wish to amend the Agreement to execute the second of the three additional one-year extension periods available to the parties.

**NOW THEREFORE**, for and in good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the County and the City hereby agree as follows:

1. Parties hereby approve the second of the three (3) available one-year extensions of the Emergency Medical Services agreement beginning on **January 01, 2026**, and terminating on **December 31, 2026**.
2. Except as modified herein, all other terms and conditions of the Agreement, remain in full force and effect. County and City ratify and confirm the terms and provisions of the Agreement as amended herein.
