## SECOND AMENDMENT TO REIMBURSEMENT AGREEMENT

This Second Amendment to Reimbursement Agreement (this "Amendment"), effective as of \_\_\_\_\_\_\_, 2023, is made by and between MISSION REDEVELOPMENT AUTHORITY (the "Authority"), a local government corporation created and organized under the provisions of the Texas Transportation Corporation Act, Chapter 431, Transportation Code, and authorized and approved by the City of Mission, Texas pursuant to Resolution No. 1021 adopted on November 26, 2001, acting by and through its governing body, the Board of Directors (the "Authority Board"), REINVESTMENT ZONE NUMBER ONE, CITY OF MISSION, TEXAS (the "TIRZ"), a tax increment reinvestment zone created by the City of Mission, Texas pursuant to Chapter 311, Texas Tax Code, as amended, acting by and through its governing body, the Board of Directors (the "TIRZ Board"), and THE CITY OF MISSION, TEXAS (the "City"), a Texas home-rule city.

## **RECITALS**

WHEREAS, the Authority, the TIRZ and the City entered into that certain Reimbursement Agreement, dated November 28, 2016, as amended (the "Agreement"), relating to the financing and construction of the first phase of the widening and improvement of Inspiration Road and Military Road, and connecting roads within the TIRZ, more particularly described in the Agreement, for the benefit of the TIRZ; and

WHEREAS, the parties have determined that the costs of the project have changed, and the parties wish to amend the Agreement to provide to provide therefor; now therefore,

For and in consideration of the mutual promises, covenants, obligations, and benefits contained herein, the Authority, the TIRZ, and the City contract and agree as follows:

- 1. <u>Recitals</u>. The facts contained in the recitals to this Amendment are hereby found to be true and correct.
- 2. <u>Definitions</u>. Capitalized terms used in this Amendment shall have the meanings assigned to them in the Agreement, unless otherwise defined or the context clearly requires otherwise.
- 3. Amendment to the Agreement.
  - a. Section 3.2 of the Agreement is hereby amended to read in its entirety as follows:
    - "3.2 Project Costs. The Project Costs eligible under this Agreement shall be the City's actual design and construction costs of the Public

Improvements that are eligible for financing by the Authority under the Project and Financing Plan, not to exceed \$1,533,152.68, and shall not include interest."

- b. Section 5.1 of the Agreement is hereby amended to change "\$1,358,777" to \$1,533,152.68."
- c. Any references inconsistent with this Amendment Agreement are hereby confirmed as may be required to be consistent therewith.
- 4. <u>Agreement in effect</u>. Except as specifically provided herein, the Agreement remains in full force and effect as of its original date.
