Special Election is ordered and shall be held in the City of Mission on Tuesday, November 3, 2026, for the purpose of electing Councilmember for Place Two term to expire November, 2028.

Applications would be accepted at the City Secretary's office during the filing period beginning on Wednesday, July 22, 2026, and ending at 6:00 p.m., on Thursday, August 20, 2026.

Early voting and Election Day will be conducted at Mission Parks & Recreation Gym, 721 N. Bryan Road and Mission Boys & Girls Club Gym at Bannworth Park, 1822 N. Shary Road

Staff and Co-Interim City Manager recommend approval.
