

## 'No Parking Zone' Consideration 1500 block of Trinity Street

This report includes observations of parking on the roadway and in the neighborhood near the 1500 block of Trinity Street. Photographs were taken of the roadway and parking situation in the north, south, east and west direction of the intersection of Stewart Road and Trinity Street.

## Roadway

The 1500 block of Trinity Street runs east to west and is a 2 way roadway with one lane in each direction. The 1500 block of Trinity Street is located on the west side of the intersection of South Stewart Road and Trinity Street. The intersection has signs that indicate a 4 way stop where all vehicles traveling east, west, north and south must come to a complete stop. The roadway has painted lines and designated stopping points.

## **Observations**

I, Traffic Investigator Samuel Ybarra, was parked on the south side of the intersection (1300 Stewart Road) facing northward. I was able to view traffic and parking in all directions. I remained at that intersection from 10:19am up to 11:25am. While I was there I observed house construction taking place on the east side as well as another house with construction on the south side on Stewart Road. I observed pickups and trailers hauling construction material and machinery arriving and leaving the area, however, they were nowhere close to the area of concern and they never caused traffic congestion or disruption. I observed there to be yellow and red marker flags (refer to photographs) on the north west side of the intersection where it appears surveying vehicles may have caused the temporary parking situation, however, was not observed while I was there. I observed several persons jogging and exercising in the area on the roadway, however, never observed traffic or parked vehicles to be of concern.







