Brief Summary:

Project Timeline

- <u>December 20, 2024</u> Application for Conditional Use Permit ("CUP") submitted to the City.
- <u>January 1, 2025</u> In accordance with State and local law, notice of required public hearings mailed to all property owners within 200 feet of subject tract.
- <u>January 15, 2025</u> Public hearing and consideration of requested Conditional Use Permit by the Planning and Zoning Commission (P&Z). The P&Z approved the request subject to staff's recommendations including reducing the hours on Tuesday – Thursday to 11pm.
- <u>January 27, 2025</u> Public hearing and consideration of requested Conditional
 Use Permit scheduled before the City Council. The City Council took no action on
 the request. Applicant needs to apply for the late hour permit through TABC and
 then come back to City Council for reconsideration.
- March 13, 2025 In accordance with State and local law, notice of required public hearings mailed to all property owners within 200 feet of subject tract.
- March 24, 2025 Public hearing and consideration of requested Conditional Use Permit scheduled before the City Council.

Summary

- The site is located approximately 214' south of E. 4th Street along the east side of Shary Road.
- Per Code of Ordinance, to extend the hours of operation and to have live music requires the approval of a Conditional Use Permit by the City Council.
- The applicant would like to extend the hours of operations and add Live Acoustic & Karaoke music. Access to the site is of two 25' driveways off of N. Shary Road along the north and south side of the property. The last conditional use permit for the sale & on-site consumption of alcoholic beverages approved for this location was approved by the City Council on January 8, 2024 for a period of 2 years.
- The proposed hours of operation are as follows: Sunday Monday from 7:00 am to 11:00 pm, and Tuesday - Saturday from 7:00 am to 2:00 am
- Staff: 5 employees
- Parking: In reviewing the floor plan, there is a total of 76 seating spaces, which

require 25 parking spaces. The parking is held in common and there are 80 parking spaces that are shared with the other businesses,

- No incidents have been reported for this business.
- The Planning staff has not received any objections to the request from the surrounding property owners. Staff mailed out (18) legal notices to surrounding property owners.
- In accordance with the zoning ordinance, the P&Z and City Commission may impose requirements and conditions of approval as are needed to ensure that a use requested by a Conditional Use Permit is compatible and complementary to adjacent properties.

Staff Recommendation:

Staff recommends approval of the request subject to compliance with the following conditions:

- 1. Life of use with the understanding that the permit can be revoked due to non-compliance.
- 2. Must comply with all City Codes (Building, Fire, Health, Sign, Noise, etc.)
- CUP not transferable to others.
- 4. Hours of operation are Sunday Monday from 7:00 am to 11:00 pm and Tuesday Saturday from 7:00 am to 2:00 am


