I will provide updated notarized forms to the City Secretary whin three (3) days, listing personnel changes, providing personnel additions and deletions by the wrecker company and;

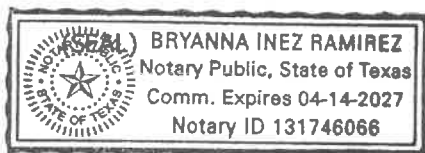

In addition, valid wrecker permits will be immediately revoked, if wrecker company owner(s) and/or wrecker drivers are found to be in violation of the above, and/or the wrecker company owner(s) fail(s) to notify the City Secretary of violations of the provisions of the above section.

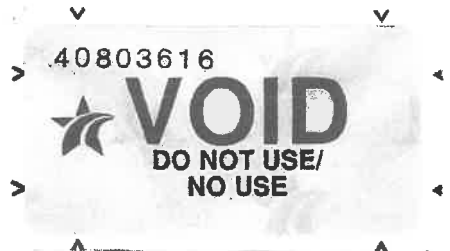


