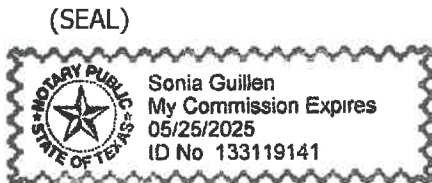

I will provide updated notarized forms to the City Secretary within three (3) days, listing personnel changes, providing personnel additions and deletions by the wrecker company and;




