The Mission Police Department is seeking authorization to lease and later purchase (2) 2025 Silverado Craw Cab pickup trucks for the Mission Police Department fleet from D&M Leasing Company (buyboard contract #744-24). The (2) 2025 Silverado Craw Cab pickup trucks will be leased for a 12-month period and paid off after the leasing period ends. The principal purchase cost amount of each vehicle is \$54,595.75. The interest to be paid for each vehicle is \$1,960.89. The purchase cost amount is \$113,113.28, including the interest paid during the leasing period. The lease expenditure will be made with \$100,000.00 deriving from Stonegarden FY2024 Grant funds and \$13,113.28 deriving from federal asset forfeiture treasury funds. Any remainder costs will derive from capital outlay.
