ORDINANCE NO. ____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MISSION, TEXAS AUTHORIZING AND APPROVING A TRANSFER FROM THE DESIGNATED PURPOSE FUND'S AMERICA RESCUE PLAN ACT OF 2021 (ARPA) GRANT AWARDED BY THE U.S. TREASURY TO THE GENERAL FUND AS REIMBURSEMENT FOR QUALIFYING GOVERNMENTAL SERVICE EXPENDITURES.

WHEREAS, the City of Mission ("City), as a home-rule municipality, has the power and authority of local self-government pursuant to Article XI, Section 5 of the Texas Constitution; and

WHEREAS, pursuant to the laws of the State of Texas, including Section 51.001 of the Texas Local Government Code, the Mission City Council ("Council") has the authority to adopt an ordinance that, among other things, is good for the government, peace, or order of Mission, Texas; and

WHEREAS, pursuant to 31 Code of Federal Regulations ("CFR") Part 35 (Pandemic Relief Programs), the American Rescue Plan Act of 2021 ("ARPA") funds granted provide an allowance for revenue loss to be used for government services; and

WHEREAS, on January 8, 2024, the Council approved an appropriation of \$1,951,832 in ARPA funds granted by the U.S. Department of the Treasury ("Treasury") to the City to be used for government services as allowed by Treasury guidelines.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF MISSION, TEXAS THAT:

SECTION 1. TRANSFERS OF FUNDS

In accordance with the Final Rule of the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) Funds awarded by the Department of Treasury, as part of ARPA, stated in 31 CFR Part 35 Regulation Identification Number (RIN) 1505–AC77, municipalities may utilize awarded funds for revenue loss. The final rule offers a standard allowance for revenue loss of up to \$10 million, not to exceed a recipient's SLFRF award amount, allowing recipients to select between a standard amount of revenue loss or complete a full revenue loss calculation. Recipients that select the standard allowance may use that amount for government services.

For the expenses of the City the following sums of money are hereby transferred from the funds herin named and for the purposes herein specified to the General Fund as reimbursement for qualifying governmental services, subject to the laws governing the same:
