## 4. ACTION ITEMS

a. Periodic Update - Tier 3 City Required Middle Housing Types

Ms. Tainio and the Planning Commission discussed the required middle housing types and which types fit best in Millwood's residential zones.

b. Periodic Update - Continued discussion on modifications to Draft Comprehensive Plan Land Use & Housing Elements

Ms. Tainio explained that she had contacted the Department of Commerce regarding the ACS and the Census data not matching and will get the information to the Commission when they respond.

Ms. Tainio and the Commission discussed administrative design reviews, Millwood's Historic District, including development standards for the Historic District, middle housing and UR-2 Density.

c. Periodic Update - Discussion on modifications to Draft Comprehensive Plan Historic Preservation, Transportation, & Essential Public Facilities Elements

Ms. Tainio explained that the changes to the Historic Preservation section were the addition of Ordinance #524 passed in 2021 that were not incorporated into the Comprehensive Plan.

Ms. Tainio and the Planning Commission discussed the numerous updates to the Transportation section including the addition of Ordinance # 525, bus stop locations, sidewalks, complete streets information, street redesignations, level of service standards, Argonne road safety improvements, Centennial Trail connection, extending the Millwood Trail, and GMA updates that include multimodal transportation, ADA evaluations, active transportation as well as roads.

 d. Periodic Update - Discussion on modifications to Draft Comprehensive Plan Capital Facilities / Utilities Element

Ms. Tainio explained that there had been a goal listed in the last two Comprehensive Plans to have a Capital Facilities Plan. She presented a draft Capital Facilities & Utilities Plan for the Commission's review. They discussed the Water System Plan, stormwater, the Urban Forestry Management Plan, Public Works Inventory and Utilities.
