a. Periodic Update - Public Hearing on Draft Comprehensive Plan

Ms. Tainio discussed the steps that have been completed to finalize the Comprehensive Plan and made note that there is one public hearing left.

The Commission discussed the transportation forecast information, the accuracy of the households by income and race data as well as Table 11-8 of the Millwood Capital Plan provided by Welch Comer regarding Peak Month Consumption Per Connection. Additionally, the Commission expressed concerns regarding additions to the Historic Preservation Commission chapter due to the adoption of Ordinance 524 and discussed getting feedback from City Council to reopen the HPC chapter of the 2026 Periodic Update to make changes.

Public Hearing Remarks:

Tina Siefert, 10507 E Empire, suggested adding a footnote below the water consumption report to help clear up any confusion that may transpire from the information provided by Welch Comer.
