# Subject:Adopt Final Assessment Roll and Award Contract for the 2025 StreetImprovement Project (City Project No. 01-25)

### Issue:

The City Council is advised to hold the public hearing and consider adopting the assessment roll for the 2025 Street Improvement Project, City Project No. 01-25.

### **Overview:**

The 2025 Street Improvement Project, City Project No. 01-25, is proposed to be funded by various City Funds, supported, in part, by special assessments. The improvements proposed for construction in 2025 are summarized below:

- Reclamation of the Pine Circle, Trillium Lane East, Trillium Lane West, Trillium Way, and Wind Ridge Trail,
- Partial curb and gutter replacement in the Trillium area,
- Replacement of one gate valve and the addition of three gate valves in the Trillium area, and
- Installation of inflow/infiltration barriers in Pine Circle.

On February 18, 2025, the City Council ordered the preparation of the proposed assessments and called for the hearing on the assessments. The amount to be assessed was declared to be \$504,273.64.

Proposed special assessments are based on the city's assessment policy, and on direction provided by the City Council at the October 7, 2024 work session and the February 18, 2025 city council meeting. Proposed assessment rates are as follows:

#### Mission Statement:

The City of Minnetrista will deliver quality services in a cost effective and innovative manner and provide opportunities for a high quality of life while protecting natural resources and maintaining a rural character.

At the February 18, 2025 meeting city council directed staff to evaluate if Parcel 6 and Parcel 7 should both be assessed. These parcels were included in the preliminary and final assessment rolls because they are shown as separate Property Identification numbers (PIDs) in the County system and both have frontage to Wind Ridge Trail.



Figure 1. Parcels 6 and 7 of the assessment roll

Parcels 6 and 7 were platted one lot: Lot 2, Block 1 Wind Ridge. According to the Hennepin County 1/2 Section Map the school district boundary coincides with the common lot line between Parcels 6 and 7. Hennepin County verified Parcels 6 and 7 are one lot, they just have two PIDs. Per the Hennepin County Auditor's records two PIDs are required due to different taxation from the two different school districts. Staff recommends that Parcel 7 be removed from the assessment roll.




Figure 3. Hennepin County 1/2 Section Map (2023).

#### **Mission Statement:**

The final assessment roll is attached and includes a list of the properties to be assessed and the proposed assessment amounts.

# Fiscal Impact:

The improvements are proposed to be funded through a combination of City Funds and special assessments to benefitting properties. The assessment will be levied for a 20-year period at an interest rate of 3.9 percent per annum; per City Council direction 2% was not added to the interest rate because the city is not bonding for the project.

### **RESOLUTION NO. 29-25**

# RESOLUTION ADOPTING ASSESSMENT FOR THE 2025 STREET IMPROVEMENT PROJECT, CITY PROJECT NO. 01-25

WHEREAS, pursuant to proper notice duly given as required by law, the Council has met and heard and passed upon all objections to the proposed assessment for the assessable portion of City Project No 01-25, which includes the reclamation of the Pine Circle, Trillium Lane East, Trillium Lane West, Trillium Way, and Wind Ridge Trail; partial curb and gutter replacement in the Trillium area; replacement of one gate valve and the addition of three gate valves in the Trillium area, and the installation of inflow/infiltration barriers in Pine Circle.

# NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF MINNETRISTA:

- 1. Such proposed assessment, a copy of which is attached hereto and made a part hereof, is hereby accepted and shall constitute the special assessment against the lands named therein, and each tract of land therein included is hereby found to be benefited by the proposed improvement in the amount of the assessment levied against it.
- 2. Such assessment shall be payable in equal annual installments extending over a period of 20 years, the first of the installments to be payable on or before the first Monday in January 2026 and shall bear interest at the rate of 3.9 percent per annum from the date of the adoption of this assessment resolution. To the first installment shall be added interest on the entire assessment from November 1, 2025 until December 31, 2026. To each subsequent installment, when due, shall be added interest for one year on all unpaid installments.
- 3. The owner of any property so assessed may, at any time prior to certification of the assessment to the County Auditor, pay the whole of the assessment on such property, with interest accrued to the date of payment, to the City Treasurer, except that no interest shall be charged if the entire assessment is paid any time on or before November 1, 2025; and he/she may, at any time thereafter, pay to the City Treasurer the entire amount of the assessment remaining unpaid, with interest accrued to December 31 of the year in which such payment is made. Such payment must be made before November 15 or interest will be charged through December 31 of the next succeeding year.
- 4. The owner of any property so assessed may, at any time prior to certification of the assessment of the first installment to the County Auditor, pay to the City Treasurer any portion of the assessment. The remaining unpaid balance shall be spread over the period of time established by the Council for installment payment of the assessment.

5. The clerk shall forthwith transmit a certified duplicate of this assessment to the County Auditor to be extended on the property tax lists of the County. Such assessments shall be collected and paid over in the same manner as other municipal taxes.
