Subject: Purchase of a Multiple Interactive Learning Objective System

(MILO)

When the Police Department was constructed, an area was dedicated to becoming a possible gun range. This area has remained empty since the opening of the Police Department. Staff studied the space and discovered that when the trap system is accounted for, the range would not be very long. A range is also expensive to build, operate, and maintain.

Staff began to search for alternative uses for this space. One idea was to use technology that can act as both a training tool and an electronic range. The benefit of this is that its purchase price is far lower than that of a firearms range, and the ongoing costs are also significantly lower. In addition, live ammunition is not used. This means there is no dangerous lead that needs to be cleaned up, and the cost savings from not having to purchase large amounts of additional ammunition.

Former Director Falls was introduced to the MILO System while attending a police conference, and further research on the system continued upon his return.

Of important note is that this system is far more than an electronic firearms range. It is a multi-faceted, instructor-led educational system. Some of the main goals of the system are to help officers improve their crisis management. Learning objectives such as deescalation and situational awareness are common themes.

The system has over 1000 multi-branching scenarios. Many of these scenarios are very common in police work in any city. Some scenarios include training with people in mental health crisis, juvenile offenders, techniques to calm people with PTSD, and Autism. In addition, there are scenarios that increase cultural understanding and understanding of inherent bias.

The system also helps officers consider their surroundings while dealing with stress, distractions, and aids in understanding bystander awareness. There is resiliency training to help officers recalibrate their nervous system, which results in a more resilient officer.

Mission Statement:

Experts in constitutional law are part of the MILO team. As such, MILO has a softwareembedded "knowledge base" that is a repository of legal information for students during training to help officers better understand the law and reduce liability.

MILO also assists with encouraging community policing and duty to intercede training.

MILO was developed using research-based technology. A Doctor of Educational Technology is on staff full time and conducts research with neuroscientists and behavioral health experts. The research team also includes law enforcement and military officers.

As part of the purchase price, MILO conducts on-site "train the trainer" training.

This means training staff will receive all the information needed at our Police Department to train fellow officers. The system can be set at different training levels depending on the officer's experience. Proficiency levels can include beginner, novice, experienced, expert, and master. This system will help officers at all levels of experience become better and safer in their duties and thereby make the public safer.

As mentioned, besides the immersive training with scenarios, MILO can also be used for tactical skill-building and virtual firearms proficiency thereby improving shooting skills through various drills and exercises.

The total cost for the system was quoted on June 4th to be \$97,165.00.

MILO also offers an extended warranty for \$4858.25 per year.

The MILO System requires a much smaller footprint than a full range. This means the rest of the former range can be used for much-needed storage, as the PD has no large, dedicated storage areas.

The goal is to pay for the construction and the MILO system itself using public safety dedicated grant monies and drug task force monies, also dedicated to unbudgeted law enforcement purchases.
