<b>July 25 (Friday)</b>	Tax Rolls Due from Chief Appraiser	
<b>August 7 (Thursday)</b>	Tax Rates Due to City Council	Post on website. No Council action needed.
<b>August 29 (Friday)</b>	Deadline to File Proposed Budget	Must wait 30 days to adopt. Does not require a vote by Council but a vote to approve the Proposed Budget is fine.
<b>September 18 (Thursday)</b>	Last day to Publish Notice of Budget Hearing	Must be 10 days between publication and hearing
<b>September 22 (Monday)</b>	Last day to Approve Proposed Tax Rate	
<b>September 22 (Monday)</b>	Last day to Publish Notice of Tax Rate Hearing	
<b>September 24 (Wednesday)</b>	Last day to Publish Notice of Meeting to Adopt Tax Rate if no hearing is required	
<b>September 28 (Sunday)</b>	Last day for Budget Hearing	
<b>September 29 (Monday)</b>	Last day to Adopt Budget	
<b>September 29 (Monday)</b>	Last day to Adopt Tax Rate
