- (s) Electronic message display signs. Electronic message display signs may be permitted in the commercial and industrial zoning districts subject to the following requirements:
- (1) Operational limits. Such displays shall be limited to static displays, messages that appear or disappear from the display through dissolve, fade, moving message or scroll modes, or similar transitions and frame effects that have text or visual, non-animated visuals, that appear to move or change in size, or be revealed sequentially rather than all at once.
- (2) Minimum display time. Each message on the sign must be displayed for a minimum of five seconds.
- (3) Lighting intensity. In no case shall the lighting intensity of any sign, whether resulting from internal illumination or external illumination shall not exceed 700 Lux more than one foot from the sign when measured with a standard light meter perpendicular to the face of the sign.
- (4) No temporary signs. No electric message display signs may be used on temporary signs.
- (5) Limitations near residences. Electronic message display signs located on property adjacent to any residential district shall not be operated between the hours of 10:00 p.m. and 6:00 a.m. This requirement shall not apply to any premises at which the business is operating during these hours.
- (6) Animation limitations. The image or message of the sign does not flash or have animation or television type of screen effects.
- (7) Size limitations. The area of the electronic message display does not exceed one half of the entire size of the sign.




