Agenda Item: A Resolution Authorizing Contracting With Rent.Fun, LLC To Provide Kayak Rental Services To The Moberly Parks And Recreation Department.

Summary: We postponed seeking a kayak agreement until the boat ramp projects were near completion. We are aiming to have kayak rental services start next spring. The agreement attached from Rent.Fun covers a 5-year term which will be paid up front. Revenue sharing would be 50/50 with Rent.Fun administering the program directly and in entirety from the reservations and credit card processing to maintenance and liability waivers. The attached agreement covers single person kayaks.

This company has provided their sole source letter. Over the last 12-18 months, there has been outreach to other companies to verify the sole source criteria which confirmed this is the only known company with the capacity to deliver that will handle reservations, liability, provide the equipment and retain ownership, maintain and replace the equipment if there is vandalism or theft, and have the equipment in a fully enclosed locker.

Rentals will be able to be provided during daylight hours 6 months per year (or as weather allows) which will be an enhancement from our currently paddleboat rentals which are available only during Park Ranger hours and sometimes with delays as Rangers may have multiple customer service stops before they can get to the boat ramp. Using a digital system allows the company to remotely provide a code following the transaction through their app., allowing the customer to unlock the locker.
