

MINUTES OF THE CITY OF MOBERLY, MISSOURI CITY COUNCIL MEETING MARCH 17, 2025

The Moberly City Council met in regular session at 6:00 p.m. in the City Hall Council Chambers, 101 West Reed Street, Moberly, MO, with Mayor Lucas presiding.

All stood and recited the pledge of allegiance led by Mayor Lucas.

A motion was made by Kimmons and seconded by McKeown to adopt the Resolution. Ayes: Lucas, Kimmons, McKeown, Graff, and Skubic. Nays: none.

Monthly reports were received from various departments.

Mayor Lucas nominated the following individuals to the Historic Preservation Commission for a three-year term: Jimmy O'Loughlin for reappointment, and Libby Mattox for appointment to fill the open position of Ashley Apel. Kimmons made a motion to reappoint Jimmy O'Loughlin and to appoint Libby Mattox for three-year terms. Graff seconded the motion. Ayes: Lucas, Kimmons, McKeown, Graff, and Skubic. Nays: none.

Mayor Lucas nominated Jonique Barnett for reappointment to the Tourism Advisory Commission. Kimmons made a motion to reappoint Jonique Barnett for a three-year term to the Tourism Advisory Commission. Graff seconded the motion. Ayes: Lucas, Kimmons, McKeown, Graff, and Skubic. Nays: none.

Aaron Hess, a resident of 1213 County Road 2268, Moberly, MO, was present and addressed the Council regarding a police case. He provided an overview of a physical altercation that occurred on September 21, 2022, and expressed dissatisfaction with how the police report was written. Mr. Hess stated that he had spoken with the City Attorney regarding the matter. The Mayor requested that the City Attorney provide additional context. Mr. Thompson explained that he first spoke with Mr. Hess by phone in June or July of 2024. Mr. Hess had filed two civil cases seeking damages, both of which were dismissed. After the dismissals, Mr. Hess requested that criminal charges be brought forward. Mr. Thompson contacted the police department, which explained that their investigation did not establish probable cause for referring the case to the county prosecutor. Mr. Thompson clarified that his office can only prosecute violations of Municipal Ordinances and that, based on the police investigation, there was no basis for criminal charges. Additionally, the statute of limitations for a misdemeanor expired in 2023. Mr. Thompson stated that he would follow up with Mr. Hess after the meeting.

A motion was made by Kimmons and seconded by Graff to adjourn to a work session followed by a closed session to discuss the status of negotiated contract matters. §(610.021)(12) RSMo. Roll Call Vote: Ayes: Lucas, Kimmons, McKeown, Graff, and Skubic. Nays: none.
