## PRESENTATIONS

5. Mayor's Report: Thomas J. Hamilton, Jr.

Mayor Hamilton reported the following:

- <u>Thursday</u>, June 20<sup>th</sup> Habitat for Humanity- Celebration of the owners getting the keys to the home. Councilman Dennis was also in attendance.
- <u>Friday Sunday, June 21<sup>st</sup>-23<sup>rd</sup></u> He attended 3 days of the Girls State Softball Tournament. Our recreation staff worked diligently to make this event run smoothly.
- <u>Monday, June 24<sup>th</sup></u> He participated in a ribbon cutting ceremony for the Closet of Hope at the DSS office. This organization ensures that children going into foster care have clothes and other items. Councilman Sweatman was also in attendance.
- <u>Thursday</u>, June 27<sup>th</sup> He participated in a ribbon cutting ceremony at Swig and Swine Restaurant and the Marina Store. Councilmembers Law, Sweatman and Dennis were also in attendance.

- <u>Friday, June 28<sup>th</sup></u>- He participated in a food giveaway at the Farmers Market Pavilion.
- <u>Friday, June 28<sup>th</sup></u>- He attended a luncheon for the nonprofit Healing Farms to learn about the programs they offer and want to bring to Moncks Corner.
- <u>Saturday</u>, June 29<sup>th</sup> The Town held the 4<sup>th</sup> of July Celebration at the Recreation Complex. We had a great crowd that kept the vendors very busy. Councilmen, Dennis, Sweatman and Law were in attendance. He extended a heartfelt thank you to everyone that worked so hard to make this happen. It was a total team effort.
- <u>Friday, July 5<sup>th</sup></u> He attended the sendoff for our 9 10 year old All Star Minors and our 13 – 14 year old Dixie Boys. He thanked the Fire and Police Departments for their assistance and support.
- <u>Throughout the month of July</u> The Moncks Corner Police Department will sponsor a school supply drive. Items can be dropped off at the Police Department, located at 118 Carolina Avenue. Items being collected are pens, pencils, paper, folders, binders, crayons, backpacks, glue, tape, calculators, scissors, paints.
- <u>Thursday, July 11<sup>th</sup></u> He recently attended a luncheon hosted by the Moncks Corner Rotary Club, where he had the privilege to introduce himself and address the attendees. During the event, he provided an update on the current and upcoming activities in our Town, as well as highlighting some of the exciting future events on the horizon.

## 6. Administrator's Report: Jeffrey V. Lord

Administrator Lord reported the following:

- Park master plan for Lacey Park and the Pickle Ball Courts are close to being finalized. We will be bidding that out soon.
- The project for the Inclusive Playground is out for bid. We had a pre-bid meeting last week and 6 contractors attended. Bids are due August 6<sup>th</sup>.
- The contract has been signed for the Foxbank Mast Arms Project. It is an 18 month build because of the time it takes to get the mast arms. We hope to see some work on this project in the next couple of months.
- We have a draft budget for Council's review. He plans to schedule a budget workshop in the next couple of weeks.

Community Development Director Justin Westbrook introduced Jamie Baker as the new Deputy Building Official for the Town. He is a native of Berkeley County and Moncks Corner. He comes to the Town from the City of Charleston. Prior to his employment with the City of Charleston, he was a journeyman lineman with the Department of Defense for about 3 years and before that he was employed with Sumter Utilities for approximately 6 years. Prior to that he served with the United States Marine Corps with the rank of Sergeant. He received 8 certifications within one year during his employment with the City of Charleston. Plans are to begin the certification process for Mr. Baker to obtain his Certified Building Official soon.
