CALL TO ORDER

The regular meeting of Town Council was called to order by Mayor Michael Lockliear at 6:00 p.m.

APPROVAL OF MINUTES

Regular Meeting of Council: September 15, 2022 Motion made by Councilmember Law to approve the regular meeting minutes of September 15, 2022, seconded by Councilmember Sweatman. Motion was approved unanimously as follows:

2. Special Meeting of Council: September 22, 2022

Motion made by Mayor Pro-Tem Dennis to approve the special meeting minutes of September 22, 2022, seconded by Councilmember Sweatman. Motion was approved unanimously as follows:

REPORTS

3. Mayor's Report: Michael A. Lockliear

Mayor Lockliear reported that the temporary poles for the traffic light are going up at Foxbank. The Miracle League Field's final inspection is this Friday. The Ribbon Cutting is planned for November 21st @ 5 p.m.

4. Administrator's Report: Jeffrey V. Lord

Administrator Lord reported that the Town has received the second disbursement of ARPA Funds. The ARPA Committee will meet again to go over the estimates submitted by local businesses. November 9th is the first Coaches Appreciation Dinner to be held at the Berkeley High School Cafeteria from 7-9 p.m. Council is invited to attend. The Boat Landing at Lions Beach finally received their permit to begin construction.

NEW BUSINESS

5. Consideration: Proposal to Provide Accounting Services Staff solicited bids for accounting services of the Town's Financial Statements for fiscal years 2022 thru 2025. Requests for bids were solicited through e-mail (approximately 15 accounting firms were contacted), Town's website and SCBO.

Greene, Finney Cauley, LLP was the only firm to submit a bid with the following rates:

Staff recommended the bid be awarded to Greene, Finney, Cauley, LLP based on past experience with Greene Finney, Cauley, LLP. They have the knowledge and experience to provide excellent services to the Town.

Motion was made by Councilmember Sweatman to award the bid to Greene, Finney, Cauley, LLP seconded by Councilmember Law. Motion was approved unanimously as follows:

6. Consideration: Re-naming Peagler Way to Miracle Way Motion was made by Councilmember Kitts to rename Peagler Way to Miracle Way. Motion was seconded by Councilmember Law and approved unanimously as follows:

7. First Reading - Consider a motion to amend Chapter 8, Buildings and Building Regulations, of the Code of Ordinance.

Community Development Director Doug Polen explained that the Town recently created a Master Fee Schedule for all Town fees. As all fees should be located only on the Master Fee Schedule, staff proposes removing references to fees in Chapter 8 of the Code of Ordinances.

Motion was made by Councilmember Law to approve the proposed amendment to Chapter 8. Motion was seconded by Councilmember Sweatman and approved unanimously as follows:

OLD BUSINESS

8. Second Reading and Public Hearing: Ordinance No. 2022-09

An ordinance to annex property east of the southern terminus of Vanihayn Drive, TMS 122-00-02-009, and to zone said property R-2, Single Family Residential with Conditions.

Public Hearing: There were no comments from the public.

Motion made by Mayor Pro-Tem Dennis to approve the above ordinance to annex the southern terminus of Vanihayn Drive, (TMS 122-00-02-009), and to zone property R-2, Single Family Residential, with conditions. Motion was seconded by Councilmember Law. Motion was approved unanimously as follows:

Voting Yea: Mayor Pro-Tem Dennis, Councilmember Kitts, Councilmember Law, Councilmember Lloyd, Councilmember Sweatman, Councilmember Ware.

9. Second Reading and Public Hearing: Ordinance No. 2022-10

Consider an ordinance to annex 19.17 acres along Highway 52 at the end of Perry Hill Road, TMS 142-14-00-030, and to zone said property R-3, Single Family Attached Residential, with conditions

Mayor Pro-Tem Dennis recused himself from discussion due to ownership and vested interests in the property. He submitted his statement to Mayor Lockliear for approval.

Councilmember Law recused himself from discussion due to either professionally employed by or under contract with principal. He submitted his statement to Mayor Lockliear for approval.

Public Hearing: Ronnie Bennett of Perry Hill asked what part of Perry will be annexed. Community Development Director Doug Polen responded, the property is located at the very end of Perry Hill Road between Eloise Drive and Perry Hill Road.

Denise Aiken Daniels of Perry Hill asked if the cars will be going straight through to the end of Perry Hill? Director Polen responded yes; the road will be extended. Ms. Daniels asked, what will the speed limit be? He responded that this is a County Road and whatever the speed limit is now, will probably remain.

Julia Sims of 314 Eloise Drive, Perry Hill expressed concerns of people speeding on Eloise Drive while children are playing.

Motion made by Councilmember Kitts to approve the above ordinance for first reading to annex 19.17 acres along Highway 52 at the end of Perry Hill Road, TMS 142-14-00-030, and to zone said property R-3, Single Family Attached Residential, with conditions. Motion was seconded by Councilmember Ware.

Motion was approved by majority vote as follows:

10. Second Reading and Public Hearing: Ordinance No. 2022-11

Consider an Ordinance to rezone 10.38 acres located at the southeast corner of US Highway 52 and Shine Lane, TMS 142-00-01-021, from C-2, General Commercial, to R-3, Single-Family Attached Residential, with Conditions

Public Hearing: Elias Brown asked if there will be another exit and entrance to this development. Access will be through Shine Lane; however, improvements will be made to this entrance. Mr. Brown asked if their property will be annexed as a result. Mayor Lockliear responded no.

Motion made by Mayor Pro-Tem Dennis to approve the above ordinance for first reading to rezone 10.38 acres (TMS 142-00-01-021), from C-2 General Commercial to R-3, Single Family Attached Residential, with conditions. Motion was seconded by Councilmember Sweatman and approved as follows:

Voting Yea: Mayor Pro-Tem Dennis, Councilmember Kitts, Councilmember Law, Councilmember Lloyd, Councilmember Sweatman, Councilmember Ware.

11. Second Reading and Public Hearing: Ordinance No. 2022-12

Consider an ordinance to amend Article 2 of the Zoning Ordinance

Public Hearing: There were no comments from the public.

Motion made by Councilmember Law to approve the above ordinance. Motion was seconded by Councilmember Sweatman. Motion was approved unanimously as follows:

PUBLIC INPUT – There were no comments from the public.
