**RESOLUTION APPROVING 2026 TAX LEVY AND ADOPTING THE  
2026 GENERAL AND DEBT SERVICE FUND BUDGETS**

**WHEREAS**, the City of Maple Plain is required by State law to approve a resolution setting forth an annual tax levy to the Hennepin County Auditor; and

**WHEREAS**, the City Council held a Truth in Taxation Public Hearing on December 1, 2025; and

**WHEREAS**, the City Council has received a final budget and levy.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Maple Plain, Hennepin County, Minnesota, that the following sums of money be levied for collection in 2026 upon the taxable property in said City of Maple Plain for the following purposes:

General	\$ 1,582,091
Debt Service	\$ 415,129
<b>TOTAL</b>	<b>\$ 1,997,220</b>

**BE IT FURTHER RESOLVED** that the City Council approves the following 2026 Budgets; General Fund, and Debt Service Fund, as presented to them this evening, and such budgets shall be attached to this signed resolution for future reference; and

**BE IT FURTHER RESOLVED** that the 2025 scheduled debt levy for bond series 2021A G.O. Bonds in the amount of \$60,648 as established in Resolution 2021-12 and will be levied at a reduced amount of \$38,064, and there will be sufficient funds on hand to make the debt service payments; and

**BE IT FURTHER RESOLVED** that the 2025 scheduled debt levy for bond series 2024 G.O. Bonds in the amount of \$219,029.68 and will be levied at a reduced amount of \$127,289, and there will be sufficient funds on hand to make the debt service payments; and

**BE IT FURTHER RESOLVED** that the City Administrator is hereby authorized and directed to transmit this information to the County Auditor of Hennepin County, Minnesota, and the Minnesota Department of Revenue, if applicable, in the format requested as required by law. Adopted by the Maple Plain City Council on December 15, 2025.
