A. Liquor, THC, Tobacco Licenses

**Staff Overview**

City Administrator Schillander summarized the Liquor, THC, and Tobacco Licenses for the 2026 calendar year. Citing the addition of Kwik Trip to the 3-2 Off Sale, tobacco, & lowP. THC license with the additional dates of 12/9-12/31/25 for approval. WHPS conducted criminal background checks for the applicants at Iron Exchange, Kwik Trip, Liquor Depot, M&M Wine & Spirits, McGarry's Irish Pub & Eatery, Monies, and the Maple Plain Smoke Shop. Applicants are also required to submit proof of insurance, renewal fees, and paperwork for licensing. Staff recommends approval of all licensing, subject to final check and state approvals.

**Council Discussion**

Councilmembers inquired if McGarry's Irish Pub & Eatery had submitted the \$75 renewal fee. Staff confirmed that the renewal fee had been paid.
