 Cross-Connection Control
 Ordinance Amendment

On Monday, August 18, 2025, at 3 p.m., Mission Springs Water District will hold a public hearing at its administration building located at 66575 Second St., Desert Hot Springs, CA 92240 to consider adoption of Ordinance No. 2025-02, Amending Ordinance 93-03, Section 3 (Section 5.02.020) Definitions, Section 8 (Section 05.02.070) Fire Protection, Section 9 (Section 5.02.080) Cross-Connection Control.

Several updates have been made to the District's regulations, specifically addressing cross-connection control policies and enforcement procedures. These changes include update to Section 3.09 (Section I) to clarify terminology and align with current standards in cross-connection control. Section 8.02.11 (Section B. 11) language pertaining to check valves has been revised to reference the most recent edition of the Manual of Cross-Connection Control, published by the Foundation for Cross-Connection Control and Hydraulic Research, University of Southern California. Section 9.01 (Section A) and Section 9.04 (Section D) have been revised to align with the Cross-Connection Control Policy Handbook adopted by the State Water Resources Control Board Division of Drinking Water on December 19, 2023, and effective on July 1, 2024. The revised language now references the most recent Manual of Cross-Connection Control published by the Foundation for Cross-Connection Control and Hydraulic Research, University of Southern California. Section 9.02 (Section B) through Section 9.08 (Section H) is being revised to change backflow prevention device to backflow prevention assembly in compliance with the updated cross-connection standards.

Oral or written comments can be made at the public hearing. It is requested that any written comments be delivered to the District Secretary prior to the hearing, either by email at dpetee@mswd.org or by hand delivery to the District Offices. A copy of the proposed ordinance is available for review at the District office.
