AUTHORIZATION FOR PURCHASE OF BOOSTER PUMP CONTROL VALVES FOR THE TERRACE BOOSTER STATION

STAFF RECOMMENDATION

Authorize the General Manager to approve the purchase of six Cla-Val booster pump control valves for the Terrace Booster Station from Core & Main for a not to exceed amount of \$86,819.86.

SUMMARY

The District uses booster pump control valves for the smooth start and stop of booster pump stations. During the last maintenance cycle Water Production Department staff determined that the valves at the Terrace Booster Station were significantly deteriorated and needed to be replaced. It is requested that each of the six booster pumps at the site be equipped with new booster pump control valves to ensure continued operation and protection of the system.

ANALYSIS

The replacement valves will ensure that each booster pump starts and stops smoothly, eliminating the risk of a water hammer or surge in the distribution system. Additionally, the new valves will prevent reverse flow from the upper zones (High Northridge and High Desert View zones) into the lower Terrace zone, thereby enhancing operational efficiency and system integrity. Failure to implement these upgrades will result in operational inefficiencies and potential system disruptions/failures. Three quotes were received and attached for your review, with Core & Main being the lowest price.
