- Increase the Contract Agreement amount by \$95,500.00. The total increase of \$95,500.00 increases the Contract Agreement from a not-to-exceed amount of \$180,000.00 to a not-to-exceed amount of \$275,500.00, as detailed in Attachment 1.
- 3. Except as set forth in this Amendment, the Agreement is unchanged and shall continue in full force and effect in accordance with its terms. If there is conflict between this Amendment and the Agreement the terms of this amendment will prevail.

Construction Management and Inspection

Dear Mr. Weck:

TKE Engineering, Inc. (TKE) is providing construction management and inspection services to the District for the Project Viento Water, Sewer, Force Main, and Lift Station. The District originally requested our construction support services for a period of 125 working days. With the Project Viento construction beginning in October 2024, the requested 125 working day service period is set to expire in May 2025. However, based on the most recent construction schedule provided by the contractor, it is anticipated that construction is expected to continue through August 2025. More specifically, substantial completion is projected for June, with SCE energization in July, and start-up and commissioning in August, followed by construction closeout.

Based on the construction schedule provided by the contractor, TKE anticipates an additional 60 working days of full-time inspection, with an additional 20 working days of part-time inspection. In addition, we've included part time construction management services, assuming 4-hours per week, for the remaining 16 weeks of construction, consistent with what we have provided to date.

TKE is requesting a budget increase in the amount of \$95,500 (approximately 700 man-hours) to continue to provide construction management and inspection services, as originally proposed, through the completion of the Project Viento Water, Sewer, and Lift Station construction; see the attached fee breakdown table. Our fee is a "time and materials basis" fee amount and we

will not provide added services without prior MSWD approval. We will continue to invoice MSWD monthly in accordance with our rate schedule, not to exceed the amounts specified.

TKE is available to meet with District staff to discuss the requested extra work and the project budget upon your request. If you have any questions, please advise.
