PARTIAL ASSIGNMENT AND ASSUMPTION OF PUBLIC WATER SYSTEM IMPROVEMENT AND WATER SERVICE CONNECTION FEE CREDIT/REIMBURSEMENT AGREEMENT

THIS ASSIGNMENT OF FEE CREDITS ("Assignment") is entered into as of ______("Effective Date") by and between SKYBORNE VENTURES, LLC, a California limited liability company (formerly SKYBORNE VENTURES, LLC, a Delaware limited liability company) (herein "Assignor Developer") and LENNAR HOMES OF CALIFORNIA, LLC a California limited liability company ("Assignee Developer").

Recitals

- A. The Assignor Developer and Mission Springs Water District ("**District**") are parties to that certain PUBLIC WATER SYSTEM IMPROVEMENT AND WATER SERVICE CONNECTION FEE CREDIT/REIMBURSEMENT AGREEMENT dated August 30, 2006, recorded as Document No. 0784841 (the "**Original Agreement**"), as amended by that certain First Amendment dated March 27, 2007, recorded as Document No. 0213347 (the "First Amendment") as amended by that certain Second Amendment dated March 18, 2015, recorded as Document No. 0358292 (the "**Second Amendment**"), as amended by that certain Third Amendment dated November 15, 2021, recorded as Document No. 0688461 (the "**Third Amendment**"), and as amended by that certain Fourth Amendment dated September 6, 2022, recorded as Document No. 0392037 (the ("**Fourth Amendment**"), concerning that certain real property more particularly described therein (the "**Project Property**"). The Original Agreement, collectively with the First Amendment, Second Amendment, Third Amendment, and Fourth Amendment are referred to herein as the "**Agreement.**" Capitalized terms not otherwise defined herein shall have the meanings set forth in the Agreement.
- B. Pursuant to Section 16 of the Second Amendment, Assignor Developer desires to assign certain fee credits to Assignee Developer, subject to the terms and conditions contained in this Assignment -and the Agreement. Such fee credits are to be used in connection with the portion of the Project Property identified on **Exhibit "A"** attached hereto (the "**Property**") consisting of 286 lots and commonly known as Village 3.

Agreements

NOW, THEREFORE, THE ASSIGNOR DEVELOPER AND ASSIGNEE DEVELOPER HEREBY AGREE AS FOLLOWS:

- 1. Assignor Developer hereby assigns to Assignee Developer some but not all of its fee credits under the Agreement as provided herein. Assignor Developer hereby assigns to Assignee Developer Water Connection Fee Creditsin the amount of Two Million Seventy Nine Thousand Two Hundred Twenty (\$2,079,220.00) which is the amount of the current Water Connection Fee of Seven Thousand Two Hundred Seventy Dollars (\$7,270.00) multiplied by two hundred eighty-six (286) which shall be applied to 286 lots on the Property per attached Exhibit "B" (collectively, the "Assigned Fee Credits"). Assignee Developer intends to use all of the Assigned Fee Credits within one hundred and eighty (180) days of the execution of this Assignment and no connection fee increases are anticipated within one hundred and eighty (180) days. However, for the sake of clarity, if the Assigned Fee Credits are not used within such period anda subsequent fee increase is implemented by the District Board, the increased fee will apply (subject to application of the Assigned Feed Credits). Nothing in this is intended to freeze the amount of the Water Connection Fees that maybe charged by the District. The Assigned Fee Credits shall expire as provided in the Agreement including Section 9 of the Second Amendment. The forgoing assignment of the Assigned Fee Credits is subject to all provisions of the Agreement including, but not limited to, Section 16 of the Second Amendment and Sections 28 and 29 of the Original Agreement. Further, the District will have no liability to Assignee Developer if the Assigned Fee Credits cannot be used as a result of a violation of the Agreement, as amended, or as a result of its expiration. Following the District's approval of this Assignment, the amount of Assigned Fee Credits assigned hereby willbe transferred on the books of the District and will no longer be available to Assignor Developer.
- 2. In accordance with Section 16 of the Second Amendment, Assignor Developer and Assignee Developer hereby acknowledge and confirm for the benefit of the District: (i) Assignee Developer has purchased lots within the Project Property; (ii) use of the Assigned Fee Credits will be subject to the requirements of the Agreement; (iii) the District will have no liability to any assignee if the fee credits cannot be used as a result of a violation of the Agreement or as a result of their expiration.
- 3. All of the covenants, terms and conditions set forth herein shall be binding upon and shall inure to the benefit of the parties hereto and to their respective heirs, successors and assigns. Assignee Developer shall have the right to assign the Assigned Fee Credits to successor owners of the Property (if any).
 - 4. The District is a third-partybeneficiary of this Assignment.
