# CONTRACT AGREEMENTS WITH TKE ENGINEERING, INC. FOR ON-CALL PROFESSIONAL GENERAL ENGINEERING SERVICES

#### STAFF RECOMMENDATION

Authorize the General Manager to execute three contract agreements with TKE Engineering, Inc. for On-Call Professional General Engineering Services in the total amount of \$415,000.00 for FY2024-25.

#### **SUMMARY**

The District continues to use outside engineering consultant(s) on an as-needed basis to assist staff with District project and construction management, project design, development projects, plan and document review, special projects, and with future planning of District facilities. For FY2024-25, MSWD anticipates utilizing TKE Engineering, Inc. (TKE) for water resource activities (CVRWMG, SGMA, SNMP, Water/Wastewater Master Plans Update, et. al.), project design (GQPP Areas A & G, M-2, & D-3), and construction inspection services. The three contract agreements will be \$170,000.00 for On-Call Professional General Engineering Services, \$180,000.00 for General Engineering Services - Project Viento Construction Inspection Services, and \$65,000.00 for General Engineering Services - PODS Storage Construction Inspection Services.

### **ANALYSIS**

On March 14, 2023, staff issued a Request for Qualifications/Proposal for On-Call Professional General Engineering Services with TKE as one of the fifteen respondents. The proposals were evaluated by three MSWD staff members and TKE was selected as one of the top respondents. The top respondents were given the opportunity to propose on the construction inspection services for the Project Viento and PODS Storage projects. Based on the merits of the proposal and cost, TKE was selected for each project. These agreements do not include projects which TKE is providing services under separate agreements such as the construction management services for the RWRF, Conveyance Line, and Area M-2.

#### FISCAL IMPACT & STRATEGIC PLAN IMPLEMENTATION

The \$170,000.00 for On-Call Professional General Engineering Services has been included in the FY2024-25 Operating Budget under a variety of line items within the Water and Sewer Funds. The \$240,000.00 for Construction Inspection Services are specific to Project Viento and PODS Storage projects and will be reimbursed by the developer. This action is consistent with Strategic Plan Smart Goal 4.5-Ensure the District is prepared to react to manmade and natural emergencies.
