

# **Days Cash on Hand - April 2024 YTD**









## Impact Fees **April 2024 YTD – Amounts in Millions\***





## **Change in Net Position After Contributions April 2024– Amounts in Millions\***





# TCOS Update

- NBU filed a full Transmission Cost of Service (TCOS) Application with the PUCT on April 11, 2024
- NBU needed to file due to the fact that LCRA was terminating the transmission lease it had with NBU  $\bullet$
- Through the filing, NBU will recover those revenues through an updated TCOS rate
- **NBU last filed a full TCOS in 2017** lacksquare
- NBU is anticipating increasing its TCOS revenue of \$1,666,838 per year to \$3,698,142 lacksquare


