**Board of Public Utilities:** There are two seats opening, with terms to expire December 31, 2029. The Board meets on the first and third Tuesday of each month at 4:00 pm

Terry Campbell and Ed Brown have re-applied.

**Planning Commission:** There are three seats opening, with terms to expire December 31, 2029. The Commission meets on the first Wednesday of each month at 4:00 p.m.

Michael Wright and Will Bosboom have re-applied, and Allen Cox has applied.

**Park & Recreation Commission:** There is one seat opening, with a term to expire December 31, 2029. The Commission meets on the third Monday of each month at 4:00 pm.

Jesse Rodriguez has applied.

**Cemetery Advisory Board:** There are a total of four vacancies, as follows:

3 current vacancies - two with terms expiring December 31, 2026, and one with a term expiring December 31, 2027  
1 seat opening, with a term to expire December 31, 2029.

The Cemetery Advisory Board meets quarterly in January, April, July and October on the third Thursday at 3:00 p.m.

**Housing Commission:** There remains one vacancy with a term to expire December 31, 2027. The Commission meets on the fourth Wednesday of each month at 4:00 pm.
