Title: HACN Resolution No. 2024-6-HACN

A Resolution of the Housing Authority of the City of Needles Removing and Replacing the Admissions and Continued Occupancy Plan (ACOP), the Administrative Plan for Housing Choice Voucher

(HCV) Program, and the 2024-2025 Annual Plan.

**Background:** The City of Needles Housing Authority (HACN) received notice from the U.S. Department of Housing and Urban Development (HUD) regarding updating and amending the following HACN plans and/or policies in order to comply with current HUD regulations:

- Admission and Continued Occupancy Plan (ACOP)
- Administrative Plan for Housing Choice Voucher (HCV) Program (Admin Plan)
- > 2024-2025 Annual Plan (Annual Plan)

HUD has made changes to such programs as the Violence Against Women Act (VAWA), the Housing Opportunities Through Modernization Act (HOTMA), the Implementation of National Standards for Physical Inspection of Real Estate (NSPIRE), and the Veteran Affair Supportive Housing (VASH) program, in addition to other programs, that should be reflected in HACN plans and/or policies.

HACN effectuated notice via publication of a public hearing, to be held in the Council Chambers at the Needles Civic Center complex, located at 1111 Bailey Avenue, Needles, California, on **April 9, 2024**, at 6:00 p.m. The purpose of the public hearing is to provide an opportunity to the public to comment on the proposed updates to the ACOP, the Admin Plan, and the Annual Plan.

At the Housing Commission meeting held on March 27, 2024, members unanimously recommended that the Needles Housing Authority Board of Commissioners approve and adopt the revised Admissions and Continued Occupancy Plan (ACOP), the Administrative Plan for the Housing Choice Voucher (HCV) Program, and the Annual Plan for 2024-2025.
