Prices based on regular wage rates during normal working hours between 7am and 5pm, two phases, no weekend or after hour work has been figured. Based on good accessibility to indoor ladder access, load, and staging near building.

1.1-Contractor will supply all necessary labor, materials, and equipment to complete the following Sarnafil 60 mil White PVC Roof System as follows:

1.1 Scope Of Work:

• Remove existing two (2) layers Built-Up Cap sheet roofing material including wall flashings, down to wood deck and haul away all debris. Area discussed at job walk attached herein. Abatement is included per the Asbestos Abatement Report Dated April 8th, 2023.

- Scope includes small pop out roofs on the building noted herein.
- Replace dry rot or damaged wood decking. Please note that this will be done at an additional charge based on the wood being replaced and is to be negotiated prior to commencing replacement.
- Install 1/2" sloped tapered polyisocyanuate insulation behind equipment curbs for cricketing per manufactures specifications.
- Mechanically attach one-layer 1/4" Dens Deck cover-board over polyiso per manufacturers specifications.

• Mechanically attach one (1) layer of Sarnafil S-327 White, 60-mil. PVC Single-Ply Membrane per manufacture's specifications.

• Fully-adhere one (1) layer of Sarnafil G459, White, 60-mil. PVC Single-Ply Membrane at parapet walls & mechanical curbs using low VOC bonding adhesive per manufacturers specifications.

• Flash exhaust fans, drains, and pipe penetrations per manufacturer's specifications. Seal and caulk all terminations.

• Install new 24g Galv. counter flashing at mechanical roof curbs to achieve proper membrane termination per manufacturers requirements.

• Install up to 126' ln. ft. walk pad included per plans.


• Install new 24-gauge Kynar finished (standard colors only) 16" stretch out coping metal with a 22 gauge galvanized cleat to the top of parapet walls.

- Install new Galvanized metal counter flashing as needed to existing Reglets per manufacture's specifications.
- Clean up and haul away all roof debris.
- New Sarnafil roof to have a two (2) year Contractor warranty against leaking due to workmanship.
- New Sarnafil roof to have a Twenty (20) yr. manufacturer's NDL warranty on labor and materials.

Exclusions: Abatement and or testing of any kind, Patching and repairing of any roof, All Sheet metal not specifically mentioned above, Light weight insulating concrete of any kind, Reglets (re-use existing), Lead sheets or Lead flashings (not needed), Copper or Stainless Steel flashings, Gutters, Leader heads, Down spouts, Splash pans or blocks, Solar

(not needed), Copper or Stainless Steel flashings, Gutters, Leader heads, Down spouts, Splash pans or blocks, Solar panel Removal or Reinstallation, Skylights, Deck replacement, Wood Nailers, Wood Blocking, Raising of any equipment

curb or platform, Insulation other than what is specifically called out above, Tapered insulation (done by framing), Supply or install of Roof hatch, Roof accessories, Vapor barrier, Expansion joints, Crickets, Any wood work Not called out above, Waterproofing, Electrical Work of any kind, Deck Wall or Traffic Coatings, Any mechanical work including disconnect and reconnect, Duct repair or sealing, Drain supply or installation, Interior Damages, Interior protection, Temporary Roofing of any kind, Water testing, Scaffolding, Over time Wages, Permits, Shop Drawings, Allowances, and Bonding. Please note if bonding is required, our bonding rate for a project this size is 2.5%
