Background: The City of Needles Housing Authority (HACN) received notice from the U.S Department of Housing and Urban Development (HUD) regarding updating and amending the following HACN plans and/or policies in order to comply with current HUD regulations: ➤ Admission and Continued Occupancy Plan (ACOP) ➤ Administrative Plan for Housing Choice Voucher (HCV) Program (Admin Plan) ➤ 2024-2025 Annual Plan (Annual Plan)			
HUD has made changes to such programs as the Violence Against Women Act (VAWA), the Housing Opportunities Through Modernization Act (HOTMA), the Implementation of National Standards for Physical Inspection of Rea Estate (NSPIRE), and the Veteran Affair Supportive Housing (VASH) program, in addition to other programs, that should be reflected in HACN plans and/or policies.			
HACN effectuated notice via publication of a public hearing and an open house, to be held in the Council Chambers at the Needles Civic Center complex, located at 1111 Bailey Avenue, Needles, California, on March 27, 2024 , at 4:00 p.m. The purpose of the open house is to provide an opportunity to the public to comment on the proposed updates to the ACOP, the Admin Plan, and the Annual Plan; to introduce the Veterans Affairs Supportive Housing (VASH) program to the public; and to engage in outreach to landlords regarding participation in the VASH program
