WHEREAS, the governing bodies desire to update the list of individuals currently serving in the authorized positions identified in the foregoing resolutions to ensure LAIF records accurately reflect current personnel.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Needles, the Board of Directors of the Needles Public Utility Authority, and the Board of Commissioners of the Housing Authority of the City of Needles hereby approve the Authorized Representatives List attached hereto as Exhibit A and incorporated herein by this reference.

BE IT FURTHER RESOLVED that the Authorized Representatives List attached as Exhibit A supersedes any previously submitted authorized representative lists for purposes of LAIF account administration.

BE IT FURTHER RESOLVED that all prior resolutions authorizing designated officers and their successors in office to conduct transactions with LAIF shall remain in full force and effect.
