ORDINANCE NO. O-22-02-07

**AN ORDINANCE ADOPTING THE PORT OF NOME TARIFF NO. 16.2
TO REPLACE ALL EXISTING TARIFFS OF THE PORT OF NOME**

WHEREAS, in Title 12 of the Nome Code of Ordinances, the Nome Common Council reserves the power and authority to approve by ordinance all regulations and tariff rates pertaining in any manner to the administration of the Port of Nome; and,

NOW, THEREFORE, BE IT ORDAINED by the Nome Common Council as follows:

Section 1.

This is a non-Code ordinance.

Section 2.

The Port of Nome Tariff No. 16.2 attached hereto is hereby adopted in its entirety to replace all existing tariffs of the Port of Nome.

Section 3.

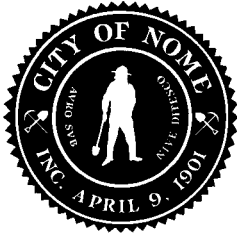
The Port of Nome Tariff No. 16.2 shall be effective upon adoption and publication.

Subject: Port of Nome Tariff No. 16.1, as submitted by the Port Commission - which through Common Council adoption, will be known as Port of Nome Tariff No. **16.2** Rules & Regulation

Background & Justification:

At their Jan 2022 and 8 Feb 2022 work sessions, the Nome Port Commission discussed various elements the port tariff rates, and elected to implement a graduated rate scale for the export of rock/gravel/sand materials. This rate scale (shown below) allows for a systematic decrease in the gravel wharfage rate, based on volume. There was extensive discussion, which ultimately resulted in the following scale:
