AMENDMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL SERVICES

This Amendment No. 1 to Contract No. K-2324-153 is between the City of Norman, Oklahoma, a municipal corporation, (hereinafter "OWNER") and H.W. Lochner, INC., (hereinafter "CONSULTANT").

WITNESSETH:

WHEREAS, the parties entered into Contract No. K-2324-153 on April 9, 2024, pursuant to which CONSULTANT was to provide professional services, including: <u>Preliminary engineering</u>, <u>design survey</u>, <u>hydraulic and hydrologic analysis</u>, <u>and geotechnical investigation services in connection with the Franklin Road Bridge Replacement</u> ("Project").

WHEREAS, Contract No. K-2324-153 was for a total amount of TWO HUNDRED TWENTY-THREE THOUSAND FIFTY AND 00/100 DOLLARS (\$223,050.00).

WHEREAS, OWNER requires various additional services from CONSULTANT, necessitating an amendment to Contract No. K-2324-153, which supplements the scope, cost, and project schedule of K-2324-153; and

NOW, THEREFORE, the parties desire to amend Contract K-2324-153 as follows:

- I. The Project shall be amended to add and supplement CONSULTANT'S provision of the professional services under the contract to also include those professional services described in the attached "Franklin Road Over Little River (NBI 09991)" dated October 23, 2024 (attached hereto as **Attachment A**, hereafter "Amendment 1 Services");
- II. The Amendment 1 Services shall be provided at a total additional cost of ONE HUNDRED THIRTY-SIX THOUSAND ONE HUNDRED SIXTY-TWO DOLLARS AND THIRTY CENTS (\$136,162.30) as set forth in Attachment A, for a new total contract amount of THREE HUNDRED FIFTY-NINE THOUSAND TWO HUNDRED TWELVE DOLLARS AND THIRTY CENTS (\$359,212.30);

Contract K-2324-153 shall only be amended as required to give full force and effect to these amendments. All other terms of Contract K-2324-153 shall remain in full force and effect.
