### **COUNCIL ANNOUNCEMENTS**

<u>Homeless Encampment</u>. Councilmember Studley said a large homeless encampment would be forced to leave their location by December 19th as ordered by the Oklahoma Department of Transportation. She said last year, the Police Department uprooted many of these same people from the north side of the encampment area. She said the reason they were asked to leave was the residents of the encampment were lighting campfires under the I-35 Bridge area, which could potentially cause structural damage to the bridge. She said the City is also aware that some of the people who live in the encampment are registered sex offenders who do their legally required check-ins and although there is a Warming Shelter, some of the people at the encampment are not allowed to go to the shelter because they are registered sex offenders and/or registered violent offenders. She asked where would they go and not knowing where they are does not make Norman a safer city.

Candlelight Vigil for Shannon Hanchett. Councilmember Studley said she attended a Candlelight Vigil on December 12th for Shannon Hanchett, the Cookie Queen, and an advocate for mental health awareness. She said she was heartbroken to find out that her death was due to another failure in our legal system. She obtained a copy of the police report and read a few lines to the audience. She said a mental health professional should have been notified to evaluate and de-escalate the situation; instead, Ms. Hanchett was arrested, taken to jail and died twelve days later while in custody at the Cleveland County Detention Center. She said Ms. Hanchett has two sons, ages 10 and 13. She said in 2020, Council voted for and reallocated funding for a Mobile Crisis Response Unit; in 2021, City Council allocated \$500,000 for a Mobile Crisis Response Unit; and in 2022, Council discussions led to the discovery of 988 and discussions about Norman being the first city to implement a Mobile Crisis Response Unit in partnerships with Continuum of Care Mental Health, which was discussed in several study sessions. She said City policies have once again failed us. She requested adding the approval of a Mobile Crisis Response Unit on the agenda so Council can approve it. She said a study session should be held before the meeting to discuss all of this.

Candlelight Vigil for Shannon Hanchett, continued. Councilmember Schueler said she attended the Candlelight Vigil and that Shannon Hanchett had moved into a small building with historical significance and revitalized the building into a place where people could come and get cookies. She said this has been a fundamental breakdown of the policies in place to protect our community members. She said the City needs to do a better job of figuring out intervention points for the system that was put into place. She would like to see our community move forward with a positive discussion about this issue. She met Shannon when they volunteered to help during the Music Festival and they bonded while they worked. She said Shannon actually lived in her ward so they became friends. She said tonight she had put on lipstick and brought her Dr. Pepper to honor Shannon.

Councilmember Lynn said he finds it repulsive to bring in television cameras to use this terrible tragedy as a political moment and try to lay this at the feet of our police officers. He reminded everyone that our police officers are men and women in blue who have the overwhelming support of the City and the majority of the City Council.

Councilmember Grant said Shannon Hanchett was laid to rest earlier today. She heard last night how much Shannon loved her Norman Community and it was reflected by the people that showed up to honor her life. She is sorry that the City failed to bring forth the necessary policy changes regarding mental health that need to be addressed. She said she helped with the People's Budget Coalition and Norman Compassionate Response Emergency Workers (C.R.E.W.) before she ran for City Council. She knows what the vision is and it is not what Shannon Hanchett experienced. She said we do not want anyone else to suffer for lack of a Norman based Mental Health Crisis Response Team, which is for compassionate response emergency workers. She said City Council rushed into funding a Bearcat without any of the details fully fleshed out and before the Request for Proposal had been sent out to start the Public Safety study. She wants to see a study session reviewing how we use 988 and our current policing and dispatching policy for mental health incidents.

Councilmember Tortorello reminded everyone that there is an ongoing investigation into Shannon Hanchett's death so we should not be making judgments in public about our police officers, whom we all support. He said we do not know all the facts. He asked the City Manager if Council used the funds that were set aside for the Mobile Crisis Unit for another project.

Mr. Darrel Pyle, City Manager, said Council used some of the money but there is still a substantial balance in that account. He said some of the funding was used for the Neighborhood Alliance and a few other small acquisitions.

Councilmember Holman said he appreciated everything that Shannon Hanchett did for our community by bringing her business to Main Street. She reused an old historic building that had been vacant for years. He said a local developer invested in the property and she was willing to bring her business there. He said Council would do everything they can to make sure that this never happens again. He said he did not want to put blame on anyone; she would want us to figure out what to do better going forward. He said for a city this size, a Mobile Crisis Response Unit is needed badly.

Candlelight Vigil for Shannon Hanchett, continued. Councilmember Peacock said Shannon Hanchett was a friend of his and this type of issue could happen to anyone. He said she deserved better and to honor her legacy, we all have to do better. He said he is joining the cause for a full review of current procedures involving mental health calls and for a full implementation of a Mobile Crisis Response Team with funding that was appropriated in 2020. He said this cannot happen again in our community. To make sure it does not happen again, we have to challenge the status quo and come up with a new approach that does not endanger people when they are in crisis. He said we are better when we are working together and this problem is going to take a great amount of community collaboration. She was an incredible person and he hopes no one loses sight of that.

<u>Happy Holidays</u>. Councilmembers Studley wished everyone a Happy Holiday and said remember to share love, kindness, and joy.

Councilmember Schueler wished everyone a Happy Holiday and urged everyone to hug their families and friends.

Councilmembers Lynn and Tortorello wished everyone a Merry Christmas. They said they would see everyone next year.

Councilmember Schueler said Councilmembers are looking for representatives from their wards to volunteer to serve on the Comprehensive Plan Update Committee and the Strongtowns Committee. Councilmember Holman said he is looking for Ward 7 residents for these committees. He said the actions that will be taken would impact Norman for the next 50 years. He said Council needs to hear all voices, opinions, and perspectives.

<u>CARE-A-VANS</u>. Councilmember Schueler congratulated CARE-A-VANS for being awarded the Human Rights Award.

Councilmember Holman asked residents to support CARE-A-VANS and encouraged people to do the research because they provide an essential service that is not duplicated currently by providing transportation to individuals that need it. He said Council needs to look at ways to support this group.

<u>Keep America Beautiful Environmental Excellence Award</u>. Councilmember Schueler congratulated Ms. Karen Chapman for being awarded the Keep Oklahoma Beautiful Environmental Excellence Award.

Councilmember Holman thanked Karen Chapman for all of the work she has done in Norman, specifically to help take care of the section of Bishop Creek that is in Ward 7. He said she has helped by picking up trash in Reaves Park. He said the volunteer service she provides is invaluable to our community. He said she helps keep the stormwater channels clean which is a vital service in Norman.

<u>Upcoming Elections</u>. Councilmember Grant said residents have a deadline of December 16th to register to vote so they can vote on January 10th, which is the OG&E Election. She encouraged everyone to read the ballot language and the history of why we are having an election.

Councilmember Holman said he would be available to discuss the Franchise Agreement Election with OG&E on January 24th and the School Bond Election that will be February 14th.

Mental Health Care. Ms. Marguerite Larson, Ward 6, said that we, as a City, have neglected to fund mental health and there are several examples of people that have had issues that escalated when the police were called. She said the police have continuously said they are not capable of taking care of mental health patients. She said if there is funding available for a better alternative, it is time for the City of Norman to do something right by taking care of the mental health problems with trained professionals.

Mr. Steve Ellis, Ward 4, said it is time to revisit public safety issues and make an important change. He said the rules are deficient if people are arrested and die in custody. He said the whole process needs to be changed and this will never happen as long as we let the Police Department run themselves. He said six years ago, the Councilmember from Ward 2 got roundly abused on the dais for daring to suggest that the City Council should have some say over police policy issues.

<u>Congratulations to Karen Chapman</u>. Mr. Steve Ellis, Ward 4, congratulated Ms. Karen Chapman for the Keep Oklahoma Beautiful Award.

Norman CARE-A-VANS. Mr. Steve Ellis, Ward 4, said Norman CARE-A-VANS won the Human Rights Award tonight for both compassionate and proactive while providing transportation to the unhoused. He said, unfortunately, the City of Norman is being neither. He said the City is pressuring private businesses to trespass our unhoused friends. He said within the week, the Norman Police Department will be helping evict from Oklahoma Department of Transportation land. He said this group has no other place to go. He said he is on the board of Norman CARE-A-VANS and he assured everyone that Norman CARE-A-VANS will be there to help those people and advocate for them.

Mr. Rob Norman, Ward 3, commended Norman CARE-A-VANS for winning a well-deserved award. He said the City reached out to Norman CARE-A-VANS and for various reasons, did not seal a deal with them. He urged City Council to revisit this because some of the criteria the City was concerned about has been corrected. He said if the City is going to rely on Norman CARE-A-VANS to provide services, the City should help fund them.

<u>Youth Baseball</u>. Mr. Rob Norman, Ward 3, said Item 28 this evening on the Consent Docket was the assignment of the service contract from Ball Clubs of Norman to the Norman Optimist Club. He thanked Council for approving this.

More Time at the Podium. Mr. John High, Ward 4, said the speakers at City Council meetings need more time. He said three minutes is not enough and anyone who speaks should be able to talk as long as they want.

<u>Shannon Hanchett</u>. Mr. Evan Dunn, Ward 4, said he did not know Shannon Hanchett but she was a Norman resident and he knows the officers and the people who work at the jail probably feel terrible. He asked what could be done so these types of events do not occur. He said the children will grow up without a mother and who knows what challenges they will face in the future.

<u>Well-Manicured Lawns</u>. Mr. Evan Dunn, Ward 4, said when he sees a well-manicured lawn at a business or home, he does not see this as beautiful, he said International Students see this and say that we are wasteful Americans. He said these lawns have productive potential that we are not utilizing. He said gardeners enjoy gardening because it grows food and creates habitat for pollinators.
