In the event Grantee abandons its need for this easement, Grantee shall notify Grantor within sixty (60) days of its decision to abandon the easement. In the event any installed facilities cease to be used and/or maintained by Grantee for a period of at least eighteen (18) months, the Grantor may terminate and vacate said easement by filing notice of termination with the Cleveland County Clerk. Grantee is responsible for any and all damages relating to or arising from installation of the facilities and shall repair any damage caused to Grantor's Property by Grantee's installation of the facilities.

Grantee, its successors and assigns shall keep, repair, and maintain the installed facilities in a proper, attractive and workmanlike manner at its sole cost. Grantee shall notify Grantor of its intent to repair or maintain the installed facilities prior to entry, unless under emergency conditions in which case notice shall be given on the first business day thereafter.

Grantor retains the right of ingress and egress to and from and across the property for uses of its own in a manner and place consistent with the rights granted under this easement and acceptable to Grantee, acceptance not to be withheld unreasonably.

As set forth herein, Grantor hereby grants Grantee an easement, for the purpose of surveying, constructing, maintaining, replacing, and operating a public right-of-way as indicated below:

To have and to hold the same unto the said City of Norman, its successors, and assigns.


