### **HISTORY**:

- 1. <u>August 23, 1960</u>. City Council adopted Ordinance No. 1246 annexing this property into the Norman Corporate City Limits.
- 2. November 22, 1960. City Council adopted Ordinance No. 1265 placing this property in the A-2, Rural Agricultural District.
- 3. May 2, 1972. City Council adopted Ordinance No. O-7172-52 placing a portion of this property in C-2, General Commercial District and removing it from A-2, Rural Agricultural District.
- 4. <u>August 24, 1982</u>. City Council accepted the proposed sanitary sewer solution for Pepco Industrial Park Addition.
- 5. <u>September 9, 1982</u>. Planning Commission, on a vote of 7-2, recommended to City Council that a portion of this property be placed in I-1, Light Industrial District and removed from A-2, Rural Agricultural District.
- 6. <u>September 9, 1982</u>. Planning Commission, on a vote of 9-0, approved the preliminary plat for Pepco Industrial Park Addition.
- 7. October 5, 1982. Council adopted Ordinance No. O-8283-17 placing a portion of this property in I-1, Light Industrial District and removing it from A-2, Rural Agricultural District.

- 9. <u>April 8, 2004</u>. Planning Commission, on a vote of 6-0, recommended to City Council the amendment of the NORMAN 2020 Land Use and Transportation Plan from Industrial Designation to Commercial Designation.
- 10. <u>April 8, 2004</u>. Planning Commission, on a vote of 6-0, recommended to City Council that a portion of this property be placed in C-2 and I-1 and removed it from I-1 zoning classification.
- 11. <u>April 8, 2004</u>. Planning Commission, on a vote of 6-0, recommended to City Council that this property be placed in C-2 and I-1 and removed it from I-1 zoning classification.
- 12. <u>April 8, 2004</u> Planning Commission, on a vote of 6-0, recommended to City Council the preliminary plat for Franklin Business Park Addition be approved with alley waiver of lots greater than one (1) acre.
- 13. <u>May 11, 2004</u>. City Council adopted Ordinance No. O-0304-62 placing a portion of this property in C-2, General Commercial District and removing it from I-1, Light Industrial District.

- 16. May 12, 2011. Planning Commission, on a vote of 9-0, recommended amending the NORMAN 2025 Land Use and Transportation Plan from Industrial Designation to Commercial Designation.
- 17. May 12, 2011. Planning Commission, on a vote of 9-0, recommended placing the remainder of this property in C-2, General Commercial and removing it from I-1, Light Industrial zoning classification.
- 18. <u>May 12, 2011</u>. Planning Commission, on a vote of 9-0, recommended to City Council the approval of the request to waive alley requirements and approval of the preliminary plat for Franklin Business Park Addition.
- 19. <u>July 12, 2011</u>. City Council amended the NORMAN 2025 Land Use and Transportation Plan placing this property in Commercial Designation and removing it from Industrial Designation.
- 20. <u>July 12, 2011</u>. City Council adopted Ordinance No. O-1011-48 placing this property in C-2, General Commercial District and removing it from I-1, Light Industrial District.

- 21. July 12, 2011. City Council approved the preliminary plat for Franklin Business Park
- 22. <u>September 6, 2018</u>. The Development Committee approved the preliminary plat for Franklin Business Park Addition.

### **IMPROVEMENT PROGRAM:**

- 1. <u>Fire Hydrants</u>. Fire hydrants will be installed in accordance with signed plans. Their locations are approved by the Norman Fire Department.
- 2. <u>Permanent Markers</u>. Permanent markers will be installed prior to City acceptance of street improvements.
- 3. <u>Sanitary Sewers</u>. Sanitary sewers will be installed in accordance with signed plans and City and Oklahoma Department of Environmental Quality standards.
- 4. <u>Sidewalks</u>. Sidewalks will be located and constructed adjacent to the proposed public streets.
- 5. <u>Storm Sewers</u>. Storm sewers and appurtenant drainage structures will be installed in accordance with signed plans and City drainage standards. Existing privately-maintained detention systems will be utilized.
- 6. <u>Streets</u>. Streets will be constructed in accordance with signed plans and City paving standards. An additional paved lane will be added to Flood Avenue (State Highway No. 77)
- 7. <u>Water Mains</u>. Water mains will be installed in accordance with signed plans and City and Oklahoma Department of Environmental Quality standards.

## **PUBLIC DEDICATIONS:**

- 1. Easements. All required easements are dedicated to the City on the final plat.
- 2. <u>Rights-of-Way.</u> All required street right-of-ways are dedicated to the City on the final plat.

## **DEVELOPMENT COMMITTEE INFORMATION:**

The engineer for the developer has requested the Development Committee review the program of public improvements, site plan and final plat for Franklin Business Park Addition, Section 4 and submit to City Council for consideration.

The final plat consists of eight (8) commercial lots on 15.81 acres. A small portion of Franklin Business Park, Section 3 is being replatted to provide frontage requirements to Lot 1, Block 1. This will complete the development.

There is a traffic impact fee in the amount of \$1,205 will be required to be paid prior to the filing of the final plat.
