

A RESOLUTION OF THE COUNCIL OF THE CITY OF
NORMAN, OKLAHOMA, REQUESTING THE ASSOCIATION
OF CENTRAL OKLAHOMA GOVERNMENTS TO CONSIDER
THE CITY OF NORMAN'S SELECTED TRANSIT
IMPROVEMENT PROJECT FOR FISCAL YEAR 2029 FEDERAL
SURFACE TRANSPORTATION BLOCK GRANT FUNDS

- § 1. WHEREAS, Federal Surface Transportation Block Grant for Urbanized Areas (STBG-UZA) funds have been made available for FY29 for transportation improvements within the Oklahoma City Urbanized Area; and
- § 2. WHEREAS, the Council of the City of Norman has selected a transit improvement project for the purchase of five (5) new CNG transit cutaway replacement vehicles to enhance the City's public transit vehicle fleet; and
- § 3. WHEREAS, the project's preliminary estimate of total cost is \$997,525, and Federal participation under the terms of the current Federal infrastructure funding bill, relating to Surface Transportation Block Grant Program (STBG-UZA) funds is hereby requested in the amount of \$798,020 or 80% of the project cost; and
- § 4. WHEREAS, the City proposes to use funds from the General Fund, Public Transit Sales Tax, or Capital Fund as the source of funds for the local match, which is estimated at \$199,505; and
- § 5. WHEREAS, no City funds are committed by this action; and
- § 6. WHEREAS, the City of Norman has the required matching funds available and further agrees to deposit matching funds by separate agreement with the Oklahoma Department of Transportation (ODOT); and
- § 7. WHEREAS, the City of Norman agrees, as a condition to receiving any Federal financial assistance from the Oklahoma Department of Transportation, that it will comply with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C. 2000d et seq., and all requirements imposed by or pursuant to Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, "Nondiscrimination of Federally-Assisted Programs of the Oklahoma Department of Transportation-Effectuation of Title VI of the Civil Rights Act of 1964"; and
- § 8. WHEREAS, the City of Norman assures that no qualified person with a disability shall, solely by reasons of the disability, be excluded from participation in, be denied the benefits of. Or otherwise by subjected to discrimination under any program or activity administered by the City of Norman Transit Service; and
- § 9. WHEREAS, the City of Norman further understands that acceptance of this resolution by the Association of Central Oklahoma Governments (ACOG) and the Oklahoma Department of Transportation is not a commitment to Federal funding but only registers the city of Norman's interest and intent in participation in the program application process.



NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORMAN,
OKLAHOMA:

§ 10. That ACOG is hereby requested to consider this project as a candidate for Federal funding,
and to submit the same to the Oklahoma Department of Transportation for its approval.
