- Provided background on why Norman holds its City elections in February: under state law, it is the only month that allows elections to be consistent each year while meeting the City Charter's requirement that new members be sworn in by July. Runoffs are held in April.
- Announced the grand opening of Ollie's at 12th Avenue SE and Lindsey. The property had been vacant for several years, and its reopening was noted as a positive development for the community.

 Expressed appreciation to current and former members and encouraged residents to consider serving.

MISCELLANEOUS COMMENTS

Congratulatory Remarks & Community Recognition

Rob Norman, Ward 3, commended Jason Olsen and Parks and Recreation Department for the Adaptive Sports and Recreation Baseball initiative, describing it as overdue and worth celebrating.

Marguerite Larson, Ward 6, praised Councilmember Grant for her leadership in assisting unhoused residents during severe cold weather.

Cynthia Rogers, Ward 4, congratulated recent election winners, thanked all candidates, and promoted civic engagement.

Paul Arcaroli, Ward 3, thanked City Clerk Brenda Hall for her efforts in verifying petition signatures and acknowledged her professionalism.

Property Rights, Condemnation, and Compensation

Rob Norman, Ward 3, raised concerns about eminent domain and condemnation, suggesting forthcoming legal and legislative reforms may limit government takings. Applauded the Council for delaying decisions until pending cases are resolved.

Cynthia Rogers, Ward 4, reflected on fair property compensation, emphasizing that individual valuations may differ from market assessments.

Floyd Carroll, Ward 4, voiced concerns about personal experiences with property loss.

Trey Kirby, Ward 5, advocated for due process in electrical substation siting, proposing an ordinance requiring at least a half-mile setback from residences.

Arts, Culture, and Community Identity

Richard Baxter introduced himself as founder of *Racism Stinks*. Promoted unity and cultural collaboration, announced the Norman Cultural Unity Parade on May 3rd, and emphasized supporting law enforcement to build trust. Thanked Mayor Heikkila and Deputy Chief Ricky Jackson for their support.

Dan Munson, Ward 6, suggested future Norman Forward projects honor Dr. Henderson's proclamation that Norman should be a city of love, acceptance, and respect. Proposed a public art project to reflect this theme.

Evan Dunn, Ward 7, spoke on education and inspiration, sharing personal experiences with science demonstrations, time spent in China, and his ongoing health challenges. Suggested he could serve as a Norman envoy to connect with youth on science and healthy living.

Miscellaneous Comments, continued

Fiscal and Revenue Concerns

Dan Munson, Ward 6, noted sales tax collections were down (1% overall; 5% when adjusted for inflation) and recommended implementing fare systems for fixed-route buses; requesting OU increase its contribution to the rideshare program; considering higher per-ride charges; canceling the rideshare program if OU does not increase its support; and eliminating funding for new bike racks to reduce costs.

Local Elections and Civic Engagement

Cynthia Rogers, Ward 4, announced the March 4th election for the Moore Norman Technology Center's \$90 million bond issue. Shared details about a town hall meeting at St. Stephen's United Methodist Church.

Paul Arcaroli, Ward 3, promoted the same town hall meeting and noted it would include discussion of both the appeal process and the bond issue.

Trey Kirby, Ward 5, expressed strong support for the Moore Norman Technology Center bond, citing unmet demand for trade education in fields such as electrical work. Emphasized vocational training as a pathway to reduce homelessness and improve wages.

Public Safety, Utilities, and General Concerns

Floyd Carroll, Ward 4, expressed concern about rising utility bills and frequent outages.

Trey Kirby, Ward 5, connected infrastructure decisions to community well-being, emphasizing long-term planning for safety and fairness.

Other Issues Raised

Mayumi Windler, Ward 2, reported a maintenance issue with a restroom purse hook and celebrated the safe capture of the long-missing "Interstate Princess Dog."
