#### **MISCELLANEOUS COMMENTS**

Oklahoma Turnpike Authority - Access Oklahoma (OTA)

Rob Norman, Ward 3, criticized OTA requiring political resolutions before negotiations, calling it a red flag. Urged Council not to weaken its bargaining power and to coordinate with the Attorney General, legislature, and federal government.

Amy Cerato, Ward 5, compared the community's dealings with OTA to an "abusive relationship." Stated OTA had lied under oath and could not be trusted in contracts or resolutions. Urged Council to reject any resolution and to withhold consent that OTA could misuse.

Stephen Ellis, Ward 4, criticized Council for surprising constituents with sudden decisions, including the OTA resolution. Urged more open deliberation and engagement with residents.

Tiffany Stevens, Ward 5, preferred a contract over a resolution, but warned OTA could ignore contracts as well. Cited statutes giving Council authority over road access. Argued the turnpike served unconstitutional economic development purposes and destroyed homes.

Dave Moore, Ward 5, opposed postponing action for a study session, calling it evasive. Said OTA had failed to complete the required studies and would provide no new information. Urged Council to stand firmly with citizens.

Kelly Wilson, Ward 6, opposed a resolution with OTA that would allow the taking of 13 homes in Norman. Listed longtime homeowners who would be affected. Warned resolutions provided no legal protection and contracts had been ignored elsewhere.

Pam Post, Ward 5, thanked Council for reading to her emails. Raised concerns about flaws in the postponed resolution, including references to roads outside Norman. Questioned the involvement of consultants with OTA ties and alleged inappropriate influence on staff.

Margarite Larson, Ward 6, expressed disappointment that Council did not adhere to its prior "no" vote against OTA cooperation. Raised concerns about staff actions taken without Council's awareness and warning of outside developer influence.

Cheryl Hoggatt, Ward 5, questioned OTA's shifting deadlines tied to funding and expressed concern about coercion. Raised doubts about claims that Norman needed OTA cooperation for emergency service access. Cited state statutes protecting local roadways.

Richard McKown, Ward 8, spoke against the tumpike project, recalling prior discussions of a five-lane boulevard at Indian Hills Road that would have supported commercial growth and significant sales tax revenue. He criticized the sudden pivot to the Access Oklahoma turnpike, which he called inconsistent with prior planning. He emphasized that the resolution before Council concerned access roads, not the full turnpike project.

# Homelessness & Social Services

Rob Norman, Ward 3, thanked those working on solutions for businesses and unhoused individuals.

Stephen Ellis, Ward 4, criticized Council for the lack of transparency in other issues (arena TIF, Food and Shelter). Urged more open deliberation and engagement with residents.

John Scamehorn, Ward 1, spoke about funding approaches for homeless shelters, contrasting liberal (public funding) and conservative (fiscal restraint) views. Advocated for "compassionate conservatism" through partnerships with charities and faith groups. He warned that expanding municipal funding could lead to financial strain.

# Recycling and Environmental Issues

Mayumi Windler, Ward 2, suggested repurposing plastics that are not accepted by the City's recycling program. Proposed grinding plastics into bricks for resale or donation. Shared she had been stockpiling materials for such use.

# Community and Unity

Richard Baxter, founder of *Racism Stinks* and OU student. Promoted a community collaboration event with the Norman Police Department to encourage unity and counter divisiveness. Invited residents to a cookout at Andrews Park.

Paul Wilson, Ward 1, commented on political divisiveness at all levels of government, including Norman. Urged Council and residents to avoid hate-filled discourse and to work together with elections approaching.

#### AIM Norman

Cynthia Rogers, Ward 4, criticized the AIM Steering Committee process for beginning with assumptions (22,000 additional housing units, presumption of turnpike construction). She called for Norman's growth discussions to focus on sustainability and quality of life rather than defaulting to strip malls and chain development. She highlighted housing affordability and the need for improved regional transportation, particularly bus service between Oklahoma City, the OU campus, and the law school and urged investment in commuting and cultural connections that strengthen Norman's role in the region.

# Infrastructure, Water, and Equity

Sherylann Densow, Wards 4 and 6, urged review of the City's newly released lead service line inventory, which shows disparities in safe water infrastructure. She questioned allocation of 25 years of Community Development Block Grant funds, noting promised improvements (water, stormwater, lighting, infrastructure) were not delivered to core neighborhoods. She pointed out that recent crime concerns brought new downtown lighting, while older neighborhoods remain underserved. She asked the Council to account for federal funding and ensure equity for the communities that generated the population basis for those funds.

Sustainability and Environment

Evan Dunn, Ward 7, reflected on Norman's potential to lead in sustainability. He encouraged initiatives like food forestry (already practiced in rural Oklahoma) and more environmentally respectful community standards, including discouraging gasoline-powered equipment in parks. He linked sustainability efforts to the values of Norman's international student community, who invest heavily in the city through their studies. He urged the Council to pursue bold environmental leadership as an example for the region.

Civic Engagement, Tone, and Public Discourse

Evan Dun, Ward 7, apologized for prior comments where he described a TIF proposal as "a strip mall with an arena." He acknowledged that such phrasing dismissed the work of planners and designers. He committed to offering more respectful and constructive feedback going forward. He also shared personal perspective shaped by living with a terminal illness, emphasizing gratitude, respectful dialogue, and the importance of meaningful advocacy.
