AGENDA ITEMS

 DISCUSSION REGARDING SUBMITTING AN APPLICATION FOR A HAZARD MITIGATION GRANT TO THE FEDERAL EMERGENCY MANAGEMENT AGENCY FOR PHASE I IMPROVEMENTS PLANNED TO LOWER IMHOFF CREEK AND THE USE OF AMERICAN RESCUE PLAN ACT FUNDS FOR PHASE 2 OF THE PROJECT.

Mr. Shawn O'Leary, Director of Public Works, said Imhoff Creek begins at the Robinson Street Underpass and continues to the Canadian River. The creek travels approximately 4.3 miles through Norman collecting stormwater from older sections of Norman and runs through Andrews Park. Portions of the Works Program Association (WPA) originally constructed channels that now have multiple repetitive loss structures and one mile of eroded stream bank.

Mr. O'Leary highlighted the Imhoff Creek timeline and said in 2009, the Stormwater Master Plan (SWMP) was completed; in 2015, Council approved a contract to perform hydraulics and hydrology for Imhoff Creek; in 2017, Lindsey Street Bridge was constructed and repairs to Imhoff Creek segment south of Lindsey Street was completed; in 2021, the Imhoff Road Bridge was closed due to damage (\$1.8 million); and Council approved a contract with Meshek and Associates for the design of Lower Imhoff Creek, Phase I.

The SWMP identified streams in Norman as well as significant problems and solutions along the streams. The SWMP identified five projects that include McGee Street and Lindsey Street flooding – completed; Indian Hills Road and Little River Mobile Home Park in floodplain purchased and removed – completed; reconstruction of Main Street Bridge over Brookhaven Creek – complete; Sinclair Drive over Brookhaven Creek – not completed; and IC-1 and IC-2 Imhoff Creek north of Highway 9 Bank Stabilization – not competed (IC = Impervious Cover).

Mr. Scott Sturtz, City Engineer, said the Imhoff Creek Channel Liner Repair Project was not identified in the SWMP and was considered stable in 2009. The channel was previously lined with articulated concrete block, which failed during the 2015 flooding. He said the Federal Emergency Management Agency (FEMA) provided disaster relief funds for the project and Council approved a contract with A-Tech Paving in the amount of \$451,245 on July 25, 2017, to complete repairs. He said benefits of the project include reduced erosion potential, protects adjacent properties, and is 90% federally funded.

Mr. Sturtz said the Imhoff Lower Creek Project, Phase I, from Imhoff Road Bridge downstream to State Highway 9 East consists of approximately 2,200 feet of bank stabilization at an estimated cost of \$3.8 million. Phase II from Imhoff Road Bridge North consists of 2,000 feet of bank stabilization at an estimated cost of \$4.4 million. The proposed project's design will minimize the amount of adjacent property necessary to complete the project and stream stabilization will be of done using natural product to maintain habitats, i.e., walls that allow vegetation coverage, stone drop structures/cross vanes, and native vegetation.

The current funding proposal includes \$6,402,000 from Hazard Mitigation Grant Program (HMGP) and American Rescue Plan Act (ARPA) funds in Phase I, \$1,772,000 from HMGP and Capital Improvement Plan (CIP) funds in Phase II for total costs of \$8,175.000. Phase I construction is anticipated to begin in December 2022 and completed in December 2023, while Phase II is anticipated to begin in September 2023 and completed in September 2024.

Councilmembers thanked Staff or their presentation and said they are very excited to hear the City is able to obtain funding for such a critically needed project.

The Mayor said pending litigation associated with City of Norman v. Ron Ashley, Cleveland County District Court Case CJ-2021-337, in the amount of \$210,000 was discussed in Executive Session. No action was taken and no votes were cast.
