Chair Lynn called the meeting to order and announced that item number four had been dropped from the agenda.

AGENDA ITEMS

DISCUSSION REGARDING THE FYE 2022 YEAR END CLOSEOUT.

Anthony Francisco led the discussion pointing out that the City of Norman Finance Committee also serves as the City of Norman's Audit Committee. "The City has external auditors that audit internal controls and financial positions and statements of the City to state that, in all material aspects, fairly represent the position of the City at a given point in time, in this case, at the end of the fiscal year which is June 30," Francisco said.

Joel Hassar was introduced as partner in the auditing firm Forvis and explained their firms auditing process. Hassar expects to have a final Audit Report to the Committee in December.

Francisco passed around documentation showing the City's pre-audit position. "These are the closed book figures that we have turned over to the auditors as of June 30," Francisco said. The fiscal year closed with a \$12.9 million balance in the General Fund. Francisco did point out concern for the Water Fund and asked Council to be aware of this. "We cannot continue to operate and do the Capital programs that we know we need to do and that we're planning to do within the current (Water Fund) revenues," Francisco said.

2. DISCUSSION REGARDING THE FYE 2024 BUDGET CALENDAR.

Kim Coffman presented the fiscal year end 2024 (FYE 24) Budget Calendar that outlined the upcoming budget process. April 25, 2023 will be the first public hearing regarding the budget. The second public hearing regarding the budget will be May 23, 2023. "We use to only have one public hearing but the Finance Committee, a couple years ago, decided that they'd rather have two to give the public an extra opportunity to weigh in," Coffman said. The new fiscal year begins July 1, 2023.

3. DISCUSSION REGARDING THE MONTHLY REVENUE AND EXPENDITURES REPORTS.

Anthony Francisco gave the report. Francisco stated that sales tax is flat compared to last year, but last year's sales tax was considered very high. "Flat is ok. Flat is good," Francisco said.

4. SUBMISSION OF THE REPORT ON OPEN POSITIONS.

This item was dropped from the agenda at the start of the meeting.

Chair Lynn adjourned the meeting at approximately 4:40 PM.
