Committee members narrowed down the list of candidates from 14 to four for interviews. Those being interviewed include Dianna Hutzel, Brandon Clark, Brandon Nofire and Ben Fenwick. The meeting for interviews with the candidates will be scheduled for Thursday, August 28, 2025, beginning at 4:00 p.m. Candidates will be scheduled in 60-minute intervals. The Deputy City Clerk will schedule them by lot and notify each candidate of their respective time. At the conclusion of the interviews the Committee will discuss which applicant to move forward for Council consideration.
